CALLING ATTENTION TO MATTER OF URGENT PUBLIC IMPORTANCE

REPORTED RUSSIAN INTERFERENCE WITH THE LAST GENERAL ELECTIONS IN INDIA

SHRI D. N. PATODIA (Jalore): I call the attention of the Minister of Home Affairs to the following matter of urgent public importance and I request that he may make a statement thereon:—

Reported Russian interference with the last General Elections in India.

THE MINISTER OF HOME AFFAIRS (SHRI Y. B. CHAVAN): Mr. Speaker Sir, Government have seen press reports regarding the alleged interference by Russians in the last General Elections. Efforts are being made to obtain the full text of the statements made by Mr. Y. N. Loginov. Pending their receipt and examination, it is not possible for Government to say anything in the matter. Honourable Members are, however, aware that objectionable aspects of the broadcasts made by "Radio Peace and Progress" have been brought to the notice of the appropriate Soviet authorities by the Government of India.

SHRI D. N. PATODIA: The answer is so evasive that it is necessary for me to bring some facts to the notice of the hon. Minister before he can give a suitable reply.

The Russian agencies, through various methods, have been systematically indulging into the election campaign of India as if they are fighting their own elections. According to the Hindustan Times of 4th December as referred by the hon. Minister, certain very serious insinuations have been made. Now I want to know whether, in respect of this gentleman, Mr. Yuri Modin, the Government of India had sufficient information available with them and the Russian Embassy was already asked to see that Mr. Yuri Modin was deported back from India.

Regarding the various interference of the Soviet Embassy into the election campaign of India, there have been several facts which have already come to the notice of the Government of India, and for the sake of illustration, I will quote only one and it is this.

Another report through the broadcast of June 7 "Radio Peace and Progress" com-

pared Mr. Menon to Mahatma Gandhi of India on the one hand. (Interruptions)

AN HON, MEMBER: What an imagination!

SHRI D. N. PATODIA:and on the other hand, Mr. Morarji Desai, who happens to be one of our national leaders was described as the mouth-piece of reactionary forces in the Congress and it partly hinted in the broadcast of Mr. Desai's failure to stop the murder of Mahatma Gandhi in 1948 when he was the Home Minister. . . (Interruptions)

AN HON. MEMBER: It is all wrong. SHRI D. N. PATODIA: In this respect it has been very seriously alleged that there have been various sources of financing the election campaign in India and in that process. it has come to the notice of the Goverament of India that one firm by name Nav Bharat Enterprises, 22 Ring Lajpat Nagar, New Delhi, had been syste-This firm happens to matically financing. be a contractor and does the import and export business of the Russian Government...

MR. SPEAKER: He may put his question.

SHRI D. N. PATODIA: What I will try to explain now is that the Russian propaganda did not stop with the completion of the elections in India; they are continuing the same propaganda and they are prepar-ing for the next elections in India. To that extent. I want to advise....(Interruptions)

SHRI NAMBIAR (Tiruchirapalli): Is be giving information or seeking information?

SHRI D. N. PATODIA: I am giving information to seek information.

This particular aspect of the propaganda has now been taken over by the Russian and it has been Embassy systematically reported that one Mr. Vitali Jourkins. Councillor of the Soviet Embassy, whose name has been included in the official diplomats' list, is now the liaison Moscow and the Communist Party of India and he sends regular messages to "Radio Peace and Progress"....

AN HON, MEMBER: Shame, shame.

SHRI D. N. PATODIA: and have been told that this is an information which is in the knowledge of the Home Ministry and they are watching his activi-

General Elections (C.A.)

The other method which they have now adopted is that they are preparing for the next elections. They have openly condemned the dismissal of the West Bengal Government in the "Radio Peace and Progress" programme..(Interruptions) They have also openly condemned this in the 'Radio Peace and Progress and they have suggested that whatever has happened in West Bengal is reactionary and is not proper. I think that explains the Communist Party's demand for mid-term elections in West Bengal because they want to link up mid-term elections with Soviet propaganda and Soviet ance. (Interruptions)

SHRI NAMBIAR: Nobody can give a speech.

SHRI D. N. PATODIA: Now my question is: whether the Government of India has made proper investigations into all the facts that I have mentioned and what is the result of those investigations? That is No. 1.

No. 2-Novosti which has been associating itself with these activities about which sufficient proof is there and with which PIB has entered into an agreement recently . . . (Interruptions). Is the Government of India prepared to revoke that agreement? No. 3-Is the Government prepared to disband all such associations which have been associating themselves with these activities? No. 4 is: whether the Government of India is prepared to appoint a Parliamentary Committee to go into all these investigations? (Interruptions)

SHRI NAMBIAR: He must be made the Chairman of that Committee.

SHRI D. N. PATODIA: I accept it. (Interruptions)

JYOTIRMOY BASU SHRI rose-

MR. DEPUTY SPEAKER: Mr. Basu let us hear the Home Minister now.

MR, Y, B, CHAVAN; Sir. as far as these 'Peace and Progress Radio' broadcasts are concerned, certainly we have taken up this matter with the appropriate Soviet authorities and some questions were put in

this hon. House and information was given that they have agreed to consider these matters. Naturally, if any foreign broadcast propaganda casts any reflection on the national leaders of our country, we have to protest against such matters.

SHRI HEM BARUA (Mangaldai): They have been doing that.

SHRI Y, B, CHAVAN: My only point is: whose activities we are watching, I do not think I can disclose that information here. It should not.

I would only make one point Sir. It is expected that the friendly countries should not interfere in any of our political activities and it is their claim too that they are not doing that. But, certainly, we would wish them not interfere. But, at the same time, I think we should not allow our country to become a fighting ground for any cold war propaganda of any of the foreign countries. They possibly might do that. Despite our wishes about it, they possibly might do it. It will be the duty of all political parties in this country not to get influenced by this Matter. Ultimately we have to strengthen our base in this matter and we will have to fight our political lives on the merits and demerits of our own political views.

SHRI D. N PATODIA: But we are permitting it without any objection.

भारोप यह लगाया जा रहा है कि मि॰ माडिन के॰ जी॰ बी॰ के एक ऊंचे भ्रफ़सर थे। यह चुनाव के दिनों में दिल्ली में भ्राए, गर्मी से ले कर वसन्त के बीच में रहे भौर उन्हों ने यहां ऐसे काम किये, जिन से हमारा चुनाव प्रभावित हो।

क्या गृह मंत्री के ध्यान में यह बात भी माई है कि मि॰ माडिन के नाम को ले कर कुछ जाली पत्रों की चर्चा हो रही है। यह मामला बहुत गम्भीर है। मैं गृह मंत्री से चाहता हूं कि वह बिल्कुल ठोस जानकारी के माघार पर स्पष्ट और दो-टूक उत्तर दें। क्या उन के ध्यान में यह बात माई है कि मि॰ माडिन के नाम को ले कर कुछ जाली पत्रों की चर्चा हो रही है? एक जाली पत्र बम्बई में ममरीका के कान्सुलेट के कोंसेलर-जनेरल की मोर से ममरीकी एम्बेसेडर को लिखा गया। एक पत्र ब्रिटिश हाई किमश्नर के नाम से लिखा गया जिस में श्री पाटिल से ले कर, भीर कांग्रेस नेताओं को ले कर, गम्भीर मारोप लगाए गए हैं। क्या गृह मंत्रालय ने इस बात

की जांच की है कि यह जाली पत्र लिखने वाला कौन था।

गृह मंत्री ने कहा है कि हम एलेज्ड इन्टर-फ़ीयरेंस की जांच कर रहे हैं। यह "एलेज्ड" क्या है? यह जो "रेडियो पीस एंड प्राग्नेस" प्रोग्नाम चल रहा है, वह सोवियत भूमि से चल रहा है। क्या कोई इस से इन्कार कर सकता है? कोई इससे इन्कार नहीं कर सकता है।

MR. SPEAKER: But the hon. Minister has said that Government have already protested and written to that Government.

श्री अटल बिहारी वाजपेयी: जब सरकार विरोध कर रही है, तो फ़िर "तथा-कथित हस्तक्षेप" की बात कहने का क्या मतलब है ?

श्री यशवन्त राव चक्हाण : मैं ने उस के बारे में नहीं कहा है ।

श्री अटल बिहारी बाजपेयी: मैं निवेदन करना चाहता हूं कि ग्रगर मंत्री महोदय किसी ग्रौर प्रमाण में न भी जायें, तो भी यह जो "रेडियो पीस एंड प्राग्रेस" कार्यक्रम चल रहा है, वह भारत के घरेलू मामलों में खुला हस्तक्षेप है ग्रौर सहग्रस्तित्व के सिद्धांत के खिलाफ़ है। भारत सरकार विरोधपत्र देने के बजाय रूस को यह क्यों नहीं कहती कि ग्रगर यह प्रोग्राम बन्द नहीं किया गया, तो यह एक ग्रमैत्रीपूर्ण कार्यवाही समझी जायगी ग्रौर इस से हमार ग्रौर रूस के सम्बन्धों को धक्का लगेगा?

मैं यह स्पष्ट करना चाहता हूं कि हम सोवियत रूस से मित्रता चाहते हैं और सोवियत रूस हमारी जो सहायता कर रहा है, उस के लिए हम आभारी हैं, मगर वह हमारे स्वाभि-मान, हमारी स्वतंत्रता और हमारी प्रभुसत्ता पर आघात नहीं कर सकता। न हम रूस को यह काम करनें देंगे और न अमरीका को।

SHRI Y. B, CHAVAN: I entirely agree with the hon. Member about the sentiment that he has expressed in the last part of his statement. I did not say about the alleged interference as far as the radio was con-

cerned. I have said that we have taken up this matter with them but about the other matters naturally, when I have not got the text of the statement with me, I just cannot say anything about it.

It is a fact that an officer of the name of Mr. Yuri I Modin, mentioned in the news items etc. was an officer who was designated as a counsellor, and he was in India between 12th July, 1966 and 22nd April, 1967. That is a fact. But that fact would not authorise me to say whether what is alleged is right or wrong. This fact is true and we know about it.

Certain other allegations also are made, but unless we come to any conclusion with proper evidence, I think it would be very unfair, in view of our relationship with other countries, friendly countries, both America and Soviet Russia, to make any authoritative statement on the floor of the House. That is my main difficulty,

SHRI D. N. PATODIA: On a point of order....

MR. SPEAKER: There is no point of order now.

श्री अटल बिहारी वाजपेयी: अध्यक्ष महोदय, मेरे सवाल का जवाब कहां दिया गया है ? क्या भारत सरकार सोवियत रूस से यह कहने के लिये तैयार है कि यह हस्तक्षेप बन्द होना चाहिए, नहीं तो यह अनफ़ेंडली एक्ट समझा जायेगा ?

MR. SPEAKER: The hon, Minister has already said that it should stop whether it be from America or from Russia.

SHRI RANGA (Srikakulam): It is an omnibus answer which he has given.

But the hon. Member had asked a specific question.

MR. SPEAKER: He has already said that it should stop whether it be from America or from Russia.

SHRI Y. B. CHAVAN: I did say that. SHRI D. N. PATODIA: Information is being concealed.

SHRI KANWAR LAL GUPTA (Delhi Sadar): Is the hon. Minister prepared to say that it is an unfriendly act? Let him stand up and say it.

SHRI D. N, PATODIA: Information is being concealed. The news item was published on the 4th and today is the 7th, and already about three days have elapsed, and yet information has not been collected. How does the hon. Minister explain it?

SHRI HEM BARUA: I do not want to put any question, but I just want to have a clarification from you. We had tabled a calling attention-notice.....

MR. SPEAKER: Let this calling attention-notice be over first.

SHRI HEM BARUA: We had tabled a calling-attention-notice about the involvement of Mr. Modin, but you had disallowed that. But now this question has cropped up....

MR. SPEAKER: Let this be over now. The hon. Member can write to me or meet me later on in regard to whatever calling-attention-notice he wants me to take up. Several notices are received, and do reject some and allow some others. Unfortunately, I am in that position....

SHRIMATI SUCHETA KRIPALANI (Gonda): May I seek a clarification?....

MR. SPEAKER: Let this be over first.

SHRIMATI SUCHETA KRIPALANI: I do not want to put any question, but I only want to have a clarification. Was that not the election period? Is it the normal rule to allow such things to go on during that period?....

SHRI Y. B. CHAVAN rose-

MR. SPEAKER: The Home Minister shall not answer this question. I want to be very strict.

श्रीय० व० शर्मा: श्रध्यक्ष महोदय, गृह मंत्री महोदय यह बताने की कृपा करें कि यह जो प्रचार रूस द्वारा चल रहा है श्रीर भारत सरकार ने जिस प्रचार के लिए कुछ श्रापत्ति उठाई है क्या वह निश्चित रूप में उस प्रचार को अमैत्रीपूर्ण मानते हैं? क्या वह श्रपनी नीति के श्रन्दर उस प्रचार को श्रमैत्रीपूर्ण समझते हैं हमारे देश के लिए श्रीर इस देश की म्रांतरिक शांति ग्रौर चुनाव म्रादि व्यवस्था-म्रों के मन्दर सीघे तौर पर इसे हस्तक्षेप मानते हैं?

SHRI Y. B. CHAVAN: As I said, about this radio broadcast, we have taken up the matter with the Soviet authorities. And when they have said that it is being considered by them, it would be rash on my part to come to any conclusion as to whether it is a friendly or unfriendly act. The matter is now between the two friendly countries.

It is absolutely wrong to say that because of the weakness of the Government of India, these people are doing this....

SHRI D. N. PATODIA: Are they considering the objection?

SHRI Y. B. CHAVAN: I would still make an appeal. Possibly other countries might be trying to influence our politics, but it is we who will have to be very cautious about it and not allow cold war propaganda to be taken notice of.

SHRI D. N. PATODIA: Are they considering it?

SHRI Y. B. CHAVAN: Any attempt to interfere in our politics is something very undesirable. I have no doubt in my mind about that.

दूसरा प्रश्न उठता है कि क्या जिस रास्ते यह रुपये भेजे जाते हैं उस के बारे में श्राप ने कोई जांच की है ? मैं दो रास्तों का पता आप को बताता हं। उस के बारे में क्या ग्राप जांच करेंगे? एक तो चीन से ग्रौर रूस से बहुत बडा साहित्य ग्रंग्रेजी तथा भारतीय भाषात्रों में हिन्दुस्तान में ग्राता है ग्रीर रुपयों में बेचा जाता है। क्या इस का कोई हिसाब है कि कितने रुपयों की कितनी किताबें भ्राई कितनी बिकीं, कितना रूपया यहां बिकी में मिला भीर कमीशन काट कर कितना रुपया रूस गया या कितना यहीं रह गया ? अगर सारा या कुछ, ग्रंश यहीं रह गया तो क्या चीन ग्रौर रूस के समर्थक दलों को वह दिया गया या उस का क्या हुन्ना? इसी प्रकार रूस की प्रभाव परिधि में पड़ने वाले देश जैसे कि पूर्वी जर्मनी, हंग्री, पोलैंड, बागेरिया इत्यादि हैं, उन से सोने की दर से नहीं पाउंड भौर डालर के हिसाब से नहीं बल्कि रुपयों के हिसाब से इस देश में बहुत सा माल भायात होता है। वह यहां से जो माल खरीद करते हैं वह भी रुपये में लिया जाता है। क्या इस की जांच हुई है कि जितने का माल भाता है उतना रूपया या उतने ही का माल वहां जाता है ? माल के रूप में या नकद के

रूप में क्या उतना ही वहां जाता है या नहीं ? यह दो रास्ते बहत स्पष्ट हैं कि जिन से पता चल सके कि कैसे रूस से रुपये यहां स्राये सौर बांटे गए।

इस के बाद फिर सवाल उठता है कि जब · कि यंग इंडिया में इस के बारे में पूरा व्यौरा दिया हुन्ना है, ज्ञाप चाहेंगे तो मैं करेंट भौर यंग इंडिया की प्रतियां ग्रापके पास पेश करूंगा, उस में पूरा हिसाब दिया हुआ है पार्टियों के हिसाब से । तो उस के ऊपर क्या ग्राप कृपा कर के जांच पड़ताल करेंगे ?

दूसरी बात-न्या चुनाव के दिनों में विदेशी पर्यटक चाहे वह रूस के हों, चीन के हों या दूसरे साम्यावादी देशों के हों, वह उन-उन स्थानों में घूमते रहे हैं जिन के नाम पर्यटक स्थानों के लिहाज से ऊंचे नहीं रहे हैं बल्कि वे स्थान केवल चनाव के लिहाज से ऊंचे रहे हैं?

इस के बाद क्या सरकार को पता है ... (व्यवधान) में एक मिनट में समाप्त कर रहा हं। जिस समाचार की ग्राप खोज में हैं जो उनमें उनके नाम दिए गये हैं जिन्हें रूस से पैसे मिले हैं। क्या वे नाम जब ग्राप को मिल जायें विदेशी पत्रों से तो क्या ग्राप कृपा कर के उन नामों को सदन के पटल पर रखेंगे ?

SHRI Y. B. CHAVAN: The hon, member has invited my attention to some article which appeared in the Current, Young India and some other papers. I think the article which was published by Young India most probably was reproduced by Current. I can say that this entire question of the use of foreign money in the last general election was a matter of some enquiry by the Intelligence Bureau, about which I had made a statement in the last session that that report is under the examination of the So, the allegations or the Government. reports about the use of money from the Russian side, about the use of money from the American side, in our political life were made, and that matter necessarily requires to be gone into carefully.

श्री मधु लिमये (मुंगेर) : कितने साल एग्जामिनेशन चलेगा ?

भी यशवंतराव चव्हाण: जितना वक्त आवश्यक है उतना ग्रवश्य लगेगा। वक्त कहना मेरे लिये मुश्किल है।

I would certainly say that we in the Home Ministry naturally do get information, and we certainly try to find out their modus operandi, keep a watch on this matter, and if possible to lay our hands on them, but it is very difficult for me to say whether "A" or "B" did or which modus operandi they are using. If I disclose whatever information I have, our further efforts will be frustrated, because we are trying to pursue the matter.

SHRI N. K. SOMANI (Nagpur): It is very unfortunate that the Prime Minister of our country has reduced the status of New Delhi as an extended suburb of Otherwise I do not know how Moscow we can accept the fact of our Prime Minister associating herself with the distribution of prizes to Indian citizens at the behest of Pravda. I put it to you that we have 56 Ministers in this Cabinet, and any one of the Deputy Ministers could have very well done this function. Actions and policies like this embolden the Soviet authorities to arrogate to themselves the power of running the internal affairs of this country. If by leaders and in this Parliament a lot of serious allegations have been made in respect of Yuri Modin, I would like to ask the Home Minister how long he would take to complete the enquiry in respect of Radio Peace and Progress and pronounce a judgment. I am also surprised at the answer that he gave in respect of Radio Peace and Progress talks. I know that before the last election the monitoring unit of All India Radio at Simla had sent in a report about the objectionable pronouncements of this radio. several months have passed after that, and why is the Government still saying that we are holding an enquiry? And on top of it, we have reduced our PIB to a chamcha of Moscow. And it is all going to be one-way traffic, because I am sure that whatever literature and material and propaganda stuff goes from India will be censured and would not be distributed. there. I would like to have a specific answer to this question.

SHRI Y. B. CHAVAN: The hon, Mem-

ber has not asked any question. But he has made a rather irresponsible statement, saying....(Interruption).

SHRI RANGA: What is this, Sir? The hon. Member has asked questions; why should the Minister say he has not asked any question?

SHRI Y. B. CHAVAN: Instead of giving any information or asking me any question, I must say with all the emphasis at my command that he made an irresponsible statement that New Delhi has become a suburb of Moscow. It is not so. Sometimes some people who want India to be a suburb of Washington possibly think that way. (Interruption). We do not want to be a suburb of either Washington or Moscow. We have our independent policy and we would like to follow it with determination.

SHRI KANWAR LAL GUPTA: The Central Government is responsible for solving the genuine d'fficulties of the people.

MR. SPEAKER: Order, order. It is not possible to see to all those things now.
