LANGUAGE OF THE REPORT OF THE HOUSE AND PARLIAMENTARY PAPERS

Shri S. Kandappan (Mettur): the matter which I sought to raise yesterday and for which you have kindly permitted me to make a reference today relates not to the translation that is sought to be provided inthe House for all national languages but it relates to the records that are maintained of our Parliamntary proceedings. Now the procedure is that all that happens in the House is recorded in original and is kept in the custody of the Secretariat for reference purposes as the authorised text of parliamentary proceedings. With regard to translated version—they give it on request—the original speeches delivered in English are translated into Hindi and the original Hindi speeches are translated English. The translated version contains English as well as Hindi with [Shri S. Kandappan]

the result that Members who do not understand Hindi are put to some difficulty while wanting to refer to some important discussion that took place in the House because they have to take both the original and the translated versions and find out the passages.

There is also another curious thing. After the facility of simultaneous translation that has been provided in the House, it is not uncommon for Minister, and even Members while speaking to suddenly switch on from English to Hindi. So even with regard to a particular speech made by a particular Member, if we want to make any reference to it, we have to take the two volumes and we have to find the relevant pages and trace out the lines. It is a very cumbersome and a very difficult process. Of course, I concede,—there cannot be two opinions on that-that as far as the authorised version is concerned, we cannot tamper with it though, I think, there is a lacuna in that because you have now permitted us, rightly, to deliver speeches in our national languages which are taperecorded and then translated into English. That is taken as the authorised version. But that depends upon the competence of the translators and, I hope, they are competent persons.

With regard to the translated versions, I feel that it would be very convenient and helpful if they are made only in English and English only. Those Members who prefer to have it in Hindi may be supplied with Hindi translation. Those who do not understand Hindi and who understand only English may be supplied, along with the original version, the translation of speeches made in Hindi into English. You can supply us a complete version of speeches in English. That is my only submission.

I was given to understand that it will involve some extra expenditure and all that. I find, in all the publications supplied to us from the Publications counter here and the papers

sent to us, there are double languages, English and Hindi, printed. In all the papers, there is a tendency to print Hindi and English side by side. Perhaps, it is presumed or assumed that by inter-mixing Hindi and English in the publications circulated to us, there will be an incentive for us to learn Hindi. If that is the assumption, I think, that is a misplaced and a wrong assumption. It rather creates an anti-Hindi feeling.

Shri Chandra Jeet Yaday (Azamgarh): Where is the question of creating anti-Hindi feeling in that?

Shri S. Kandappan: By having the version in English and in Hindi separately, we will be saving paper, printing and considerable labour. That is my submission.
