STATEMENT RE DISLOCATION OF TRAIN SERVICES ON CERTAIN SECTIONS OF EASTERN AND SOUTH-EASTERN RAILWAYS

The Minister of Railways (Shrl C. M. Poonachs): From 1st April to 17th June, 1967, there have been 128 cases of hold-ups of trains on Eastern and South-Eastern Railways in West Bengai. This mas resulted in detention and cancellation of several trains, causing serious inconvenience to travelling public. These cases mainly concern smuggling and looting of rice and acts of hooliganism by anti-social elements. There have also been 6 cases of robpery. 35 members of railway staff were assaulted and injured. The antisocial elements hold up trains by pulling alarm chains, disconnecting nosepipes and squatting over the track,

It hardly needs emphasis that interference with the train running and train passing staff is fraught with serious danger in that they might, in midation or loss of morale, be led to take action which may be prejudicial to safe running of trains. In any case, both punctual running of trains and rendering an efficient service to the public has become difficult. On certain occasions, use of unjustifiable hold-ups has led to complete cessation of traffic for some time over important sections.

The General Manager, Eastern Railway, approached the Chief Minister of West Bengal and apprised him of the position. The Police authorities of West Bengal were also kept informed of the developments grom time time. Having regard to the seriousness of the situation, the General Manager requested the Chief Minister to use his good offices to help the railways in maintaing the normal running of trains. As the situation was progressively deteriorating and the State Police Reserves were fully stretched due to difficult law and order position in the districts, the Inspector-General of Police, West Bengal, sent a wirles message of the Inspector-General. [Shri C. M. Poonacha]

Railway Protection Force, Railway Board, on 20th June, requesting for 8 coys. of the Railway Protection Special Force. The Inspector-General, Railway Protection Force took prompt action in moving the coys. the same day to Calcutta. The Inspector-General, Railway Protection Force flew to Calcutta on 22nd June and held a meeting with the Inspector-General of Police, West Bengal, his Additonal Inspector-General of Police, Dy. Inspectors-General of Police, Dy. Inspectors-General of Police, West Bengal, has expressed his gratitude for the prompt action taken by the Ministry of Railways.

Inspector-General of Police, West Bengal, has assured the Inspector-General, Railway Protection. Force, that the State Police will do their best to give protection to the railways against the forces of disorder.

It has been decided that the State Police will send Police parties with a Sub Inspector or Asstt. Sub Inspector to escort trains and such escorts will be strengthened with the manpower of the Railway Protection Force. The Chief Security Officers of Eastern, South-Eastern and Northeast Frontier Railways are rendeing full assistance to the West Bengal Police.

These arrangements will ensure safety to the travelling public who were subjected to untold harassments by anti-social elements and were insisting on the authorities concerned to provide necessary security during their travel by arranging armed escorts to the bassenger trains.

The Ministry of Home Affairs are also being kept informed of these developments. All possible steps are being taken to restore normal conditions for safe running of trains.

I felt that these matter should be brought to the notice of the Hoh'ble Members, as they would have been anxious to know the correct position pertaining to this area. Shri Hem Barua (Mangahiai); May I seek a clarification?

Mr. Deputy-Speaker: It is a rather disquisting situation. Instead of just now seeking clarification, if some hon member gives notice, I would permit a short discussion.

Shri Hem Barwa: Just one clarification, Sir.

Mr. Deputy-Speaker: If it is just one question, I can permit, but I see many hon. members rising up.

Mr. Deputy-Speaker: You will get an opportunity, but not now. So many members are anxious to know the state of affairs there. From the statement it appears that safe running of trains there has become difficult.

Shri S. M. Banerjee (Kanpur): This may be one-sided story. You should get the report directly from the Chief Minister of West Bengal. This House is being utilised to damn the West Bengal Government. (Interruptions).

Mr. Deputy-Speaker: All of you will resume your seats.

I have already stated that an opportunity will be given, because from the statement everybody feels that safety of travel, law and order and other matters are involved. Many members would like to put question. As I said, later on an opportunity will be provided.

Mr. Deputy-Speaker: I am not saying no opportunity would be given. Certainly opportunity will be given, but not now.

Shri H. N. Mukerjee (Calcutta North East): I would raise a point of propriety rather than of order. I cannot raise a point of order in regard to what you have chosen to say in you wisdom. However, you have let fall certain observations which appear to me to go against the sense of propriety with which proceedings of the House ought to be conducted. You have given an obiter dictum that from the statement we have beard, it seems railway travel in that part of the country has become a precarious proposition.

Mr. Deputy-Speaker: I never used the word 'precarious.' I said, safe running of trains is difficult.

Shri H. N. Mukerjee: You have said something which virtually amounts to that. This is a very highly loaded statement. (Interruption).

I know the kind of conspiracy which goes on, but it goes against the grain when the Chair chooses to make an obiter dictum of this sort. I beg of you, Sir, not to make this kind of an observation, and to behave differently.

Mr. Deputy-Speaker: When I made cetain observations I have made them keeping in view the responsibility of the Railways.

Shr H. N. Mukerjee: You have no business to make observations which can be interpreted in a very different light.

Mr. Deputy-Speake: I cannot understand why you are so much touchy.

Shri H. N. Mukerjee: Because you behaved in that fashion from the Chair. You have not forgotten that you are sitting in these benkess (Interruption).

Mr. Deputy-Speaker: I am not permitting any questions just now.

" Shr! H. N. Mukerjee: You are in the Chair now, you are not a Congress Member.

Shri S. M. Banerjee: You should expunge your own remarks.

Mr. Deputy-Speaker: Shri Banerjee, I will have to call you to order. What I have said is within my right.

Shri S. M. Banerjee: You can expunge many things. (Interruption).

Mr. Deputy-Speaker: Yes, certainly. Please resume your seat.

Shri S. M. Hanerjee: But there is a calculated attempt to maign the Government of West Bengal.

Shri H. N. Mukerjee: You are not to champion the cause of the Government from the Chair.

Mr. Deputy-Speaker: It is not a question of my becoming the champion of this side or the other. I have made an objective observations.

Shri H. N. Mukerjee: For God's sake do not forget that you are the Deputy-Speaker.:

Mr. Doputy-Speaker: I have made an objective observation. I have said that I would permit all Members concerned to put some questions or raise a discussion but at later date. There is nothing objectionable (Interruptions). I take strong exception to the remarks made by Shri Banerjee. If they are repeated I will have to take action.

Shri S. M. Banerjee: What remarks,

Mr. Deputy Speaker: Please resume

Shri V. Krishnamoorthi (Cuddalore); Sir, I rise to a point of order. The hon-Minister of Railways has made a statement regarding the railways and it is up to the House to discuss it or to put questions to elicit information. Certainly, you, Sir, the Deputy-Speaker jumped to the conclusion and made an allegation, a charge, that is dis-heartening. Is it monducive to the proper conduct of husiness of this House? That is the only thing I would the

Mr. Deputy-Speaker: I have made certain observations to show that it deserves a discussion.

Shri V. Krishnamoorthi: The House is not at all agreeing with the observation that you made. You may make that observation as Member here. After occupying the Chair you cannot make such an observation.

Mr. Deputy-Speaker: When so many hon. Members were rising in their seats, I said I would not permit any questions at this stage.

Shri V. Krishnamoorthi: You cannot presume things and make an observation.

Mr. Deputy-Speaker: What is there objectionable, I do not understand. You can see from the records what I have said. I am within my rights to make objective observations on a statement like thus.

Shri N. C. Chatterjee (Burdwan): Sir, you are perfectly within your rights to make an objective remark with regard to a particular problem. I take it that it was not your intention to cast any reflection on the efficiency, honesty or capacity of the West Eengal Government. May I have an assurance from you?

Mr. Deputy-Speaker: It was not at all my intention. I am concerned with the Raillways. Where is the question of Government of West Bengal there?

Shri Eandhir Singh: There is civil war in West Bengal. We should be ashamed of such a government if it is there. There is no Government. Trains are being locted.

Sin; Thirumala Eas (Kakinada): Sir, the hon. Minister made a factual statement giving the information that the Government could gather from the offices of the West Bengal Government, from I. G. Police West Bengal, f.om their Rallway Securit Police officers, and there was perfect co-operation between those two wings. There is no question of any appersion being east from the Chair. You have given a raing that the matter can be raised, if there was any grisvance from the other side, in a half-hour discussion or one-hour discussion and they can ask for further information from the Government. Hon, Memberg cannot transgress your ruling like this. There is no further question to be aghed on this. I say that the House should how to your ruling and pass on to the next item.

Mr. Doputy-Speaker; He should remember that members from both sides have been given opportunity.

Shri Hem Bares: Sir, I have stood up persistently, wanting to raise a point of order. Every time you said "Please sit down, I will give you an opportunity later." Now, you have passed on to the next item. That is why we feel so much about it. Wo are expressing only our agony and not anger.

Mr. Deputy-Speaker: I do not think any Member of this House would agree with your observation that you are neglected in this House. You get a major share. Railways (St.)

shri Rum Berea: Since I come from an under-developed State, there is a tendency on the part of the Chair to neglect peoples coming from an underdeveloped state like Assam. That is any complait.

Mr. Deputy-Speaker: A highly sophisticated person like you should not make such an observation, simply because you happen to come from a particular constituency. This is not being fair either to your constituency or to your State.

Already 20 minutes have been spent. It would have been ovr earlier if you had allowed questions.

Mr. Deputy-Speaker: There is no question of side here. The Minister has given an objective assessmeent of the situation,

ghr E E. Nayamar: How can we rely on that?

Shri & Kandappen (Mettur): How can you say that it is objective? Mr. Deputy-Speaker: That is my view.
