I can assure the hon. member that we are most anxious to get on with this. It is only because of the urgency of the flood resolution that it was put higher up. May I assure the hon. member, with your permission, that we shall include it in the programme for the first week of the next session?

Today's agenda is fairly long and it may not be possible to cover all the items. May I suggest that we finish the Banaras Hindu University Bill by lunch time and take up the Bihar resolution immediately after lunch? Then we can take up the three Bills for reference to the Joint Committees. I have spoken to hon. members opposite and they have agreed that they may be referred without discussion. Then we may take up the resolution on floods.
