CORRECTION OF ANSWER TO S. Q. NO. 881 DATED 2-7-1971 RE. REPORT OF ENQUIRY COMMISSION ON N. F. C. ORGANISATION

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND

SOCIAL WELFARE (SHRI K. S. RAMA-SWAMY): Following my answer to Starred Question No. 881 regarding the report of the One Man Commission of Enquiry appointed to go into various allegations pertaining to the National Fitness Corps Organisation, Shri Sat Pal Kapur asked whether it was a fact that the grade of pay recommended by the Second Pay Commission for these employees had not been given by the department so far. This question was in Hindi and I did not hear the specific teference to the Second Pay Commission in the supplementary question. The main question was about the report of the One Man Commission and not that of the Second Pay Commission. I thought that as the main question pertained to the report of the One Man Enquiry Commission, this supplementary question referred to the report of this One Man Commission. I accordingly replied that the Government was examining the report of the Commission, meaning the One Man Commission, and that a decision would be taken in the matter.

2. The correct position is that the Second Pay Commission did not make any specific recommendation regarding pay scales in the National Fitness Corps Organisation. The pay scales in this organisation were revised by the Ministry in consultation with the Ministry of Fmance on the anology of revised pay scale adopted for similar grades in other Government offices.
