MR. SPEAKER: Hon. Members, I have to inform the House of the sad demise of Shri T. R. Deogirikar, who passed away at Poona on the 27th July, 1975, at the age of 79.

Shri Deogirikar was a Member of the Provisional Parliament during the years 1950-52. Later, he was a Member of Rajya Sabha during the years 1952 to 1962. A renowned journalist, Shri Deogirikar wrote some books on Gandhian philosophy and also translated the Constitution into Marathi. He also participated in the freedom movement of the country and suffered imprisonment several times. He was associated with a number of social and cultural organisations in Maharashtra. As the then Member of Rajya Sabha, he was associated with the Committee on Public Accounts during the years 1958-60

We deeply mourn the loss of this friend, and I am sure the House will join me in conveying our condolences to the bereaved family.
