difficulty. I know something about it. The major problem is that a small farmer, a poor farmer, is one whose farming is entirely dry farming and he is not in a position to make use of an ounce of fertiliser. (Interruption). I disagree with you to that extent.

As far as kerosene is concerned, though I may not entirely accept your suggestions, as a gesture to the overwhelming view in the House, I propose to modify the proposal that I had made formerly. Of course, it is a symbolic thing. I know I will not be able to go all along the way you want me to go. This is a gesture and respect to the wishes of the Members of my party on this side and the Members on the other side as well. As a result of the taxation proposals, the duty was raised to Rs. 285 per kilo litre. Now, I propose to reduce it to R. 265 per kilo litre as a result of which we will lose Rs. 12 crores. The reduction will be approximately 2 paise per litte. I would request the honourable House to take it in the spirit in which I have given. (Interruption).

SHRI VASANTRAO PURUSHOTTAM SATHE: If you want to withdraw it, you withdraw it completely. Othewrise, you lose both, grace and money.

SHRI YESHWVANTRAO CHAVAN; I want to keep the money. I want to keep both. I want to respect the wishes of the House. The argument was as if we have done it because of adulteration. That was very unfair. I had also mentioned other things. We have to depend on the import of the material and there is the increased cost of importing it. I would request the hon. Members that though I may not have gone the whole hog, I have certainly respected the wishes of the House and, I hope, they would support me in this.
