## RE. DROUGHT IN REWA AND SIDHI DISTRICTS

RANABAHADUR SHRI SINGH (Sidhi): I want to draw the attention of the House to a matter in connection with the speech of the hon. Food Minister the other day in reply to the debate on food. The districts of Rewa and Sidhi bordering Mirzapur in eastern UP are similarly in a state of drought. I wish that when as per his statement the Food Minister undertake a trip to get acquainted with conditions in eastern UP and Bihar, he would also take time to go and have a look at things as they are in these two districts of Madhya Pradesh. Conditions there are extremely difficult. There is no irrigation at all and there has been no rainfall.

Apart from all this, another thing that is extremely troublesome in that area is that people who are supposed to take out ration cards in the rural areas are provided with only 4 kgs. of grain per head for a whole month, and as there has been no rain, foodgrains that were given to agricultural labourers by people who own land have now been stopped completely. So agricultural labour is completely dependent on the rationed foodgrains for their livelihood. The present quantum of ration is extremely limited. I wish the Food Minister makes a statement about what can be done about giving more foodgrains to agricultural labour.
