## STATEMENT RE. DOCTORS' STRIKE IN DELHI AND BOMBAY

THE MINISTER OF HEALTH AND FAMILY PLANNING (SHRI R. K. KHADILKAR): Mr. Chairman, the hon-Member, Shri K. D. Malaviya raised the issue of doctors' strike in Delhi and Bombay. I have got some information which I am going to give to the House.

As hon. Members are aware, the junior doctors in the teaching hospitals in Bombay and Poons and other places have been on strike from the 17th August 1973,

Efforts to settle this strike have not succeeded so far This junior doctors of Delhi consisting of interns, house surgeons, registrars and post-graduates held a specting on the 2nd September, 1973 in the Safdarjung Hospital and passed a resolution in which, among other things, they have decided to observe a token strike for 48 hours commencing from 8 a.m. on the 5th September 1973, that is, today. This strike is entirely in sympathy with the demands of the junior ductors of Maharashtra and there is no local demand linked up with the same. This resolution demands the immediate reinstatement of all the victimised doctors of Maharashtra, unconditional withdrawal of all charges against those doctors, immediately settlement of issues in a peaceful manner, condemnation of the alleged atrocities committed on the doctors of Maharashtra and a request for intervention by the Prime Minister.

Consequent to this notice the junior doctors working in the different hospitals of Delhi have gone on strike this morning. I will just briefly state the position in each hospital

In the All Indua Institute of Medical Sciences the normal intake of patients, even emergency and outdoor, is maintamed

In the Safdarjung Hospital there is always a great rush. The number of out-patients attended to cach day in that hospital is 2,500. The bed strength is 1,220 and another 25 were admitted, making a total of 1,245. The discharge till the morning is 340. There are 30 wards.

Hospital. The Safdarjung Hospital will be under-maintained. In all other bospitals in Delhi, we will be able to maintain normal service. There is no information about disruption of work in any hespital in Delhi.

The Delhi Nurses' Association has issued a press release sympathising with the demands of the Maharashtra in nor doctors, indicating their intention to som the strike if the demands are not met immediately. This is another threat. We are apprehensive, if the strike in Bombay is not settled soon. I am afraid, it will have repercussions all over finding. I have information from U.P., Bengal and Madras. They are also preparing for 1'

Another thing is that tomorrow the representatives of doctors from all the States are meeting m Bombay and they are thinking of forming a union So, it m an all-India move

I would like to take the House into confidence about the consequences of such a move at the present juncture

Regarding Bombay, I am trying to get the latest information. But I have failed My own information is that the strike continues and efforts of settlement have not borne any fruit. I happened to be in Bombay on the 25th of last month and on the 2nd of this month aud I tried to offer my good offices to both the sides At the first instance, there was no dialogue between the two parties. With my efforts, the doctors agreed to meet the Government representatives. On the first day, they declined even the request from two Judges to meet the Government. On the second occasion, when I went there. I found the situation was not very bealthy in the sense that doctors were not in a mood to come round because there is an intense feeling about certain alleged incidents that took place at the commencement of the talks.

The entire medical community of Bombay, the entire medical fraternity, including private hospital people, have all gone on strike. I do not know exactly but from the papers it seems that the Government of Maharashtra has maintained patient-care in tact. This is my information about Bombay

i know the House is very much exercised about the effects of this all-India strike. Therefore, I hope, both the sides will come to some settlement as early as possible.
