MR. DEPUTY-SPEAKER: The question is:

DISCUSSION RE: REPORTED AT-ROCITIES ON HARLJANS IN VA-RIOUS PARTS OF THE COUNTRY

MR. DEPUTY-SPEAKER: Now, we shall take up the discussion under rule 193 on the reported atrocities on Harijans in various parts of the country. Shri Jyotirmoy Bosu.

SHRT IYOTIRMOY BOSU (Diamond Harbour): The problem of atrocities on Harijans has become a burning problem for the whole country, and I would say that it has become more known for the failure of the Government than for their success in tackling the whole issue.

Before I quote from the Report of the Commissioner for Scheduled Castes and Scheduled Tribes for the year 1970-71. I would like to give you certain figures. According to the 1971 census, Scheduled Castes are 80 million and Scheduled Tribes are 38 million. 21.5 per cent of the total population are Scheduled Castes and Scheduled Tribes. Regionwise, the figures are as follows: Eastern region: 26.8 per cent; Northern region: 22.4 per cent; Western region: 21.4 per cent; and Southern Region: 25.2 per cent.

SHRI M. C. DAGA (Palı): discussion is on atrocities on Hariians. Why is he quoting all these figures?

SHRI JYOTIRMOY BOSU: I have just started.

MADHU DANDAVATE PROF. (Rajapur): Unless they are there, there cannot be atrocities.

SHRI M. C. DAGA: He must discuss only the point at issue, namely atrocities on Harijans. Why is he discussing irrelevant things?

SHRI JYOTIRMOY BOSU: 89 per cent of Scheduled Castes and 97 per cent of the Scheduled Tribes live in villages, and more than 80 per cent of the Scheduled Castes and 90 per cent of the Scheduled Tribes are engaged in cultivation and they work
