Shortage of Telephone Exchange Equipments

Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether the Mahanagar Telephone Nigam Limited (MTNL) is facing shortage of

telephone exchange equipments causing delay in the replacement of old exchanges;

- (b) if so, its impact on the functioning of telephone system; and
- (c) the steps taken to meet the shortage and remedial measures taken to improve the functioning of the Mahanagar Telephone Nigam Limited in the country?

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (DR. SANJAY SINGH): (a) to (c). Life expired and worn out exchanges to the tune of 89,000 lines have been replaced in the last 4 years in the Mahanagar Telephone Nigar in Bombay and Delhi. There is a programme to replace another 70,600 lines during this financial year and 98,800 during the next financial year. This is no doubt that there is a general shortage of switching equipment in the country. In spite of this the programme of replacing old and sorn-out exchanges is being carried out in MTNL. Generally the performance of old electromechanical exchanges is inferior to the electronic exchanges. Therefore the performance of the system with electromechanical exchanges remains relatively poorer than with a total system with electronic exchanges. In the total 8th Plan period, it is proposed to replace 3,18,000 lines of the old exchanges. Other measures taken to improve the functioning of the MTNL are:

Retraining of the Staff to improve the skills and Knowledge; and

Large scale input of the modern state ofart equipment.
