Assistance to Rajasthan for Checking Water Pollution

THE MINISTER OF ENVIRONMENT AND FORESTS (SHRI NILAMANI ROUTRAY): (a) and (b). The Central Government has released Rs. 27.1 lakhs to the Rajasthan State Pollution Contrl Board and Rs. 1.8 lakhs to the State Department of Environment, Rajasthan as grant-in aid for pollution control purposes during the Seventh Five Year Plan. Apart from this, during the Seventh Plan Period Rs. 85,54,619/were also released to augment the resources of the State Pollution Control Board. This assistance has been given for pollution control in general, of which, control of water pollution is a part. It is proposed to continue the assistance durig the Eighth Plan Period; the amount has not yet been finalised.
