

(b) The guidelines include :

- (i) Minimum National Standards for major polluting industries;
- (ii) Emission limits for air polluting industries and guidelines for stack heights;
- (iii) Specific industrywise documents on pollution control techniques ;
- (iv) Emission standards for vehicular exhaust ;
- (v) Use-based zoning and classification of major inter-state rivers, ambient air quality standards; and
- (vi) Strengthening of infrastructural facilities of the pollution Control Boards.

(c) No specific complaint of laxity on the part of the State Governments in implementation of these guidelines has been received.

(d) There is no such proposal under consideration of the Government.

Development of Orissa sea beach

(b) whether funds have been earmarked for this purpose in the Seventh Plan and if so, the amount proposed to be spent this year; and

(c) the details of schemes prepared in the Central Sector for the above purpose ?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI ASHOK GEHLOT) :
(a) to (c). In the Seventh Plan, the Department, as a part of its strategy to attract more tourists has decided to develop beach and holiday tourism in India. The development of the sea resorts will be undertaken jointly with the State Governments and the private sector by providing facilities for all income groups including cheap cottage type accommodation. In the Annual Plan of 1985-86, the Department has made an allocation of Rs. 25.00 lakhs for this purpose. The details will be worked out in consultation with the State Governments.

As regards the State of Orissa, a proposal for undertaking a coastal environmental study between Puri and Konarak has been received from the State Government and is under consideration of the Department.
