everbody does what he is doing, then there will be no end to it. He is a leader of the party and he should not raise it like this. I have got a number of Call Attention Notices before me. I cannot allow him to raise it like this.

Shri Baj Raj Madhok: You can ask the Government to make a statement early.

Mr. Speaker: He cannot raise it separately like this. I will certainly consider it. There are so many Call Attention Notices. Papers to be laid.
