So far, you have been good enough not to disallow them. But in view of the urgency of the matter, if at the same time a decision is not taken and no statement is coming forward . . .

Mr. Speaker: Order, order. The hon. Prime Minister was not here and therefore I said that as soon as he comes, he will make a statement. I have asked the Office to inform those hon. Members who gave notice that I have admitted it and that a statement would be made as soon as the hon. Prime Minister returns.

Shri Surendranath Dwivedy: The only thing that I have to submit in this matter is that both the hon. Prime Minister and the hon. Defence Minister have chosen to absent themselves for two or three days when Parliament is in session and such urgent matters are postponed only because of their absence. It is rather very strange.

Mr. Speaker: I do not think any harm would be done because of delay of one or two days taking place. I thought that it should be the hon. Prime Minister who should make a statement.

Shri Hem Barua (Gauhati): But there is great concern all over the country. On top of that . . .

Mr. Speaker: I appreciated that. I join in that concern; therefore, I at once admitted that.

Shri Hem Barua: We are more concerned.
