#### Small-Pox in Kerala

2822. **Shri Koya:** Will the Minister of Health be pleased to state:

(a) whether it is a fact that Small-pox was spreading in certain areas in Kerala State;

(b) whether Government have decided to wind up the activities of the National Small-Pox Eradication Programme at such a stage; and

(c) if so, the stage at which the matter stands at present?

**The Minister of Health (Dr. Sushila Nayar):** (a) No. There have been only 24 cases and 6 deaths during the months of January, February and March, 1965 in the Kerala State which has a population of about 184 lakhs (mid-year estimated population of 1965). These cases were confined to three districts, namely, Kozhikode, Trichur and Cannanore. No cases were reported from the remaining six districts.

(b) No. All the six eradication units set up during the previous year are functioning during the current year and are expected to complete the mopping up operations during the year in the entire State.

(c) Does not arise.

#### Seizure of Gold at Moradabad

**The Minister of Finance (Shri T. T. Krishnamachari):** (a) On the 8th April, 1965 gold valued at about Rs. 7,500/- was seized by the Central Excise staff from a person at Moradabad Bus stand.
