(c) the steps taken to improve those areas?

The Minister of Planning (Shri B. B. Bhagat): (a) to (c). Regarding Scarcity Areas, the possibility of taking up pilot projects for the integrated development of compact blocks is being explored by the Ministry of Food and Agriculture in consultation with concerned State Governments who have been requested to furnish necessary data. It is proposed to depute Teams of Technical Experts to assist the State Governments in preparing the pilot projects after the areas have been identified.

As regards Backward Areas, replies to the Planning Commission's letter of January 5, 1965 enclosing a list of selected indicators of dev lopment have been received from all State Governments except Madras. On the basis of the data, the question of identifying the backward areas is under consideration. After the areas have been identified, provisions for the accelerated development of such areas to the extent possible will be made in the State Plans.
