उप प्रधान मंत्री तथा रक्ता मंत्री (भी अग-व्यीवन राग): (क) से (ग) हाल के वर्षों में दिल्ली छावनी रेलवे स्टेशन के पास जेल रोड पद रेस की पटरी के ऊपर पुल बनाने की माव-श्यकता महसूस की जा रही है क्योंकि दिल्ली छावनी के उस पार बहुत सी कालोनिया बन गई है। जब रेल का फाटक बद हो जाता है तो लाइन पार करने के लिए लोगो को देर तक इतजार करना पडना है। इस पुल के निर्माण से छावनी में स्थिति कुछ रक्षा संस्थान प्रभावित होंगे इसलिए थल सेना नौपग्विहन तथा परिवहन मल्रालय, दिल्ली विकास प्राधिकरण ग्रौर दिल्ली नगर निगम के प्रतिनिधियो से इस बारे में बान-चीत की गई है। सिद्धान रूप से यह निर्णय कर लिया गया है कि सडक यानायान का सुचारू बनाने के लिए महक की सीधा करने मे ग्रौर इस पूल क निर्माण में जिन रक्षा परिसम्परितयों का तोडा जाना है उनके सबध में विन्तीय समायोजना के प्रधीन रहने हुए प्रस्तावित पूल का निर्माण उल्लिखित स्थल पर करने की अन्मान दे दी आए। इन मबध में ग्रीपचारिक स्वीकृति जिसमे की जाने वाली विन्तीय ग्रीर प्रशामनिक व्यवस्थान्नो का भी उल्लेख होगा, शीध ही दिल्ली नगर निगम का भेज दी जाएगी।

Request to supply more Crude by the United Arab Emirates

10727. SHRI P. A. SANGMA: Will the Minister of PETROLEUM. CHE-MICALS AND FERTILIZERS be pleased to state

(a) whether Government had requested the United Arab Emirates to supply more crude; and

(b) if so, the reaction thereto?

THE MINISTER OF PETROLEUM. CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA); (a) and (b), Minister of Petroleum, Chemicals and Fertilizers visited UAE in November, 1978. As a result of his visit. UAE agreed to increase the quantum of crude supplies from one million tonnes contracted for in each of the years 1975-1978 to 1.5 million tonnes during 1979. At the request of the Minister of Petroleum, Chemicals and Fertilizers, the UAE Oil Minister has also agreed to consider the possibility of further enhancing the level of crude supplies during next year.

10728. SHRI SHAMBHU NATH CHATURVEDI: Will the DEPUTY PRIME MINISTER AND MINISTER OF DEFENCE be pleased to state:

(a) whether it is proposed to evict about one hundred and fifty Scheduled Cast? familie_g at present residing on Plot No. 280 MEO land Nai Basti, Tila Baluganj, Agra; have notices been served on them for vacation of the land;

(b) if so, the reason therefor;

(c) what alternative arrangements have been made for rehabilitating them; and

(d) will Government ensure that they ar_c not thrown out until alternative accommodation or sites for construction ar_c provided for them?

THE DEPUTY PRIME MINISTER DEFENCE MINISTER OF AND (SHRI JAGJIVAN RAM): (a) to (d). 150 persons have encroached upon defence land in Nai Basti, Tila Baluganj, Agra, comprising Survey No. 280 in the excised area of Agra Cantonment. The Military Estate authorities had initiated action under Public Premises (Eviction of Unauthorised Occupants) Act against them. On representation, it has been decided to stay eviction action and to transfer the land with some re-adjustment, limited to 50 sq. vards each to 75 persons who had occupied the land upto 1973-74 on payment of current market value and rent for the past occupation. The cases of the remaining occupants are also under consideration.

Price of Chloramphenicol

10729. SHRI SAEED MURTAZA: Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

(a) whether it is a fact that in 1978 the CPC was supplying L-Base at Rs. 475.00 per kg. ex godown and the price of Chloramphenicol so manufactured was fixed at Rs. 480.00 per kg.;

(b) whether Government are aware that the prices of L-Base in the international market has increased and the landed cost is about Rs. 600.00 per kg.; and

(c) if so, how do Government justify its action in announcing the price of Chloramphenicol Powder at the same old level?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) Yes, Sir.

(b) Yes, Sir.

(c) In the context of the freeze on the prices of bulk drugs including Chloramphenicol Powder and the re-cent increase in the ci.f price of L-Base (Penultimate intermediate for manufacture of Chloramphenicol Powder) Government have made arrangements with the State Chemicals and Pharmaceuticals Cooperation of India Ltd. whereby in respect of units which hold actual users import licences of sufficient validity under which they could import L-Base and which provide CPC with the needed letter of authority CPC will import L-Base and supply the same at a price of Rs 475 per kg. ex-godown. Under this arrangement Actual Users would be in a position to sell Chloramphenicol Powder to the CPC at a price of Rs. 460/per kg. and yet earn a reasonable margin of profits.

Subsidy on L-Base

10730. SHRI GOVINDA MUNDA: Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to refer to the reply given to Unstarred Question No. 8392 on 24th April, 1979 and state:

(a) whether licences of one to three month's validity would be acceptable to CPC for subsidy of L-Base under the arrangement; and (b) if not, then how do Government ensure that the units importing themselves would not be discriminated?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) The period of validity of import licenses should normally be of three months duration which is the lead time taken by CPC for arranging imports. No subsidy would be payable to the units availing the above facility as supplies would be effected by the CPC at a price of Rs. 475/- based on which the present Chloramphenicol Powder price ex-L-Base has been fixed.

(b) Since the actual users have been provided the option to procure their requirements of L-Base from the CPC at a price of Rs 475/- per kg., provided that they surrender their import licences and undertake to supply Chloramphenical Powder to CPC at a price of Rs 460/- per kg, the question of discrimination does not arise
