Broadcast of News regarding Chinese attack on Vietnam

10739. SHRI K. A. RAJAN: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether it is a fact that the news about the Chinese attack on Vietnam on February 17, was not broadcasted in AIR or T.V. till that night; and
- (b) if so, what is the reason therefor?

THE MINISTER OF INFORMA-TION AND BROADCASTING (SHRI L. K. ADVANI): (a) and (b). The first confirmed News Agency report regarding the Chinese Military Operations against Vietnam came only around 9.28 p.m. on February 17. 1979. By then, the main English 9 00 p.m. and Hindi 8,45 pm bulletins had already gone on the air. The news agency despatches together with the B.B.C. report broadcast at 930 p.m that day were utilised and a news item was broadcast by AIR in the earliest next bulletin at 11.00 p.m. The confirmed news was used in all the news bulletins thereafter. In all the External Services bulletins during the night this item was the main story.

Only two daily News Bulletins are telecast from Delhi Doordarshan, one in Hindi at 8.00 p.m. and the other in English at 9.45 p.m. By the time these News Bulletins were put out on February 17, 1979, no authentic and confirmed news about the Chinese attack on Vietnam was available with Doordarshan,
