this grade have no promotional avenues;

(b) whether it is also a fact that as a result of great stagnation, lot of frustration has developed in this cadre; and

(c) if so, what steps Government propose to take to give some incentive to this cadre like introduction of selection grade as introduced in other cadres of service?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND DEPARTMENT OF PARLIA-(SHRI MENTARY AFFAIRS VENKATASUBBAIAH): (a) All Assistants with approved service of 8 years or more and who are within the range of seniority belonging to the Central Secretariat Service are eligible for promotion to the Section Officers' Grade under the Central Secretariat Service Rules, 1962. Some Assistants who have put in 15-20 years service are, however, awaiting promotion.

(b) The Staff Side in the Departmental Council of the Department of Personnel and Administrative Reforms have made some representations regarding stagnation in the Assistants' Grade.

(c) The question of introducing a Selection Grade for the Assistants is under consideration.

'News Item "Clamour in Jhargram"

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): (a) Yes, Sir.

(b) and (c). The Government of West Bengal have enquired into the matter and a statement, on the basis of information furnished by them, is laid on the Table of the House.

Statement

For the last few years the tribal leaders of Midnapore, Bankura and Purulia districts of West Bengal and the adjoining districts of Bihar and Orissa have been agitating for a separate Jharkhand State. The organisations which have been spearheading the movement are the Jharkhand Mukti Morcha and Jharkhand Yuba Morcha. Of late, following the disturbances in Assam and Tripura, the Jharkhand Mukti Morcha have considerably intensified their organisational activities. They are holding regular meetings in different parts of Jhargram Sub-division of Midnapore district. The Party is utilising local issues relating to distribution of land, recording of sharecroppers, elimination of Adivasi traders from the Jubilee Market of Jhargram town, employment facilities in Jhargram Paper Mills, etc. A disturbing feature is that the movement has recently developed an anti-Bengali Character. However, the Jharkhand Mukti Morcha has publicly denied any link with such activities. The Mahators of Midnapore district, who are not tribals, have made common cause with the Santhals in their demand for Jharkhand State.

It is reported that some British, French, West German and Dutch Missionaries and social welfare organisations have been aiding this movement and organising the tribals to agitate on pro-tribal issues. The district Magistrate, Midnapore. in a recent report has intimated that increasing number of foreigners and Missionaries are visiting Jhargram. He has also reported that a number of voluntary organisations, financed by foreign countries and institutions, are working in Jhargram Sub-division without keeping the district authorities informed of their activities. Some of the organisations have been doing valuable work in the tribal areas but taking advantage of their philanthropic activities, some Christian Missionaries are working for conversion of the tribals.

Inclusion of Peruvannan Community of Kerala in List of Scheduled Castes
