Potentiality of Cashew Nut Shell Liquid

- *59. SHRI K. A. RAJAN: Will the Minister of INDUSTRY be pleased to state:
- (a) whether Government are aware of the potentiality of cashew nut shell liquid (CNSL) as a raw material for plastic industries: and
- (b) what is the estimated annual use of CNSL in India, as against annual production?

THE MINISTER OF STATE IN MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) Yes, Sir.

(b) The estimated annual production of Cashew Nut Shell Liquid is 15,000 tonnes and the use within the country is of the order of 2,000 to 3,000 tonnes.

Implementation of Autonomous Dis. trict Council Act in Tripura

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): (a) and (b) The Chief Minister of Tripura has written to Prime Minis. ter describing the background in which this law was enacted by the State Assembly and sought her blessings and co-operation for its early implementation. This Act is a State law and State Government are competent to implement it on their own.
