The Chief Rector has been requested to nominate his representative. representatives of the Court can be elected only after the Court has been constituted. All other members of the Executive Council are ex-officio and are to be formally notified as such.

III. ACADEMIC COUNCIL: Steps have been initiated for the election of students on the Academic Council. An Election Officer has already been appointed to conduct the elections.
