which is one-fourth of total arrival of eggs in Delhi markets.

Financial assistance at rate of Rs. 5 lakhs per district is also provided to States/Union Territories for setting up of a suitable organisation for marketing of eggs and poultry under the Special Livestock Production Programme which is in operation in 68 alstricts in 19 States/one Union Territory. The scheme is mainly intended for benefitting small/marginal farmers and agricultural labourers, Schedulen Castes and Scheduled Tribes.

The provision of marketing facilities for milk produced in the rural areas forms the main part of the integrated cattle-cum-dairy development project, viz. Operation Flood I and Operation Flood II sanctioned by the Government of India. Under these projects, the Producers' Co-operative Societies provide the outlet for the milk produced by the members and this milk is processed and marketted through urban dairies in major areas of demand Under Operation Flood I, 9000 Producers Cooperative Societies of the Anand pattern have been set up. Under Operation Flood II, about 155 districts are expected to be covered involving 10 million farm families.

Apart from the above there is a International Development Association (IDA) assisted project under which dairy projects in the States of Rajasthan, Madhya Pradesh and Karnataka are assisted for setting up Milk Producers' Cooperative Societies on the Anand pattern.

Infra-structural assistance limited to 10 per cent of the allocation under IRD Programme is also available for developing essential marketing linkages for dairy and poultry.
