Supply of Iron ore to U.S.S.R.

*391. SHRI CHINTAMANI PANI-GRAHI: Will the Minister of COM-MERCE be pleased to state:

- (a) whether India has supplied 3 lakh tonnes of iron ore to USSR against a trial order placed by them;
- (b) whether the ore supplied has been found suitable to their requirement:
- (c) whether fresh orders for supply of ore have been received from that country; and
 - (d) if so, the details thereof?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) Against the contract concluded with USSR in February, 1980, for supply of 2 million tonnes of iron ore to that country during March-December 1980, a quantity of 1.52 million tonnes has been delivered upto November, 1980. The balance quantity is expected to be shipped during the current month.

- (b) Yes, Sir.
- (c) and (d). This matter has yet to be discussed with them.

Excise duty on dye manufacturing Units

(a) whether any representations have been received from the Dye-stuff manufacturing Association in the mat-

ter of excise duty required to be paid by dye manufacturing units in Gujarat from April, 1978 retrospectively;

- (c) whether similar claim has been made by Government in respect of dye manufacturing units in other States?

Employment of ex-servicemen in Public Undertakings

- (c) the number of such ex-servicemen who have been provided suitable jobs in the public sector undertakings and in private industry under the charge of his Ministry?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI A. P. SHARMA): (a) Necessary instructions in this regard have been issued to the Public Undertakings under the administrative control of Ministry of Tourism and Civil Aviation. As far as private Employers in Hotel and Tourism industries are concerned, the Ministry has no control over rerecruitments made by them.
