Memorandum from seafood exporters

•491-A. SHRI E. K. IMBICHIBAWA: Will the Minister of COMMERCE be pleased to state:

(a) have Government received any memorandum, representation, or complaint from the seafood exporters who are registered as small scale industrialists;

(b) whether Government are aware that the large scale sector have begun a division under the small scale sector for the export of seafoods; and

(c) how many out of the small scale sector engaged in 1970 for the export of seafood, have stopped the business and the reasons for their stoppage?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) The Government had recently received a memorandum from the Seafood Exporters Association regarding the impact of high cost of diesel on exports of marine products.

(b) The Marine Products Export Development Authority have informed that they are not aware of any such development.

(c) According to the information available, out of a total of 209 units in the small scale sector engaged in the export of seafoods during 1970, 123 small scale units have not exported Marine Products during 1979-80 for a variety of reasons including Mismanagement, Financial constraints, Inadequacy of raw material supply and Inter-se competition in the export sector. However, 470 more new small scale units have entered the business.

Committee for Promotion of Exports of Small Sectors Products

+492 SHRI AMARSINH RATHAWA:

Will the Minister of COMMERCE be pleased to state:

(a) whether Government had appointed a Committee for the promotion of exports of the small sectors' products;

(b) if so, what are the terms and conditions for exporting small sectors' products;

(c) the names of products which have been selected for export; and

(d) the names of agency through whom this export will be made?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) Yes. Sir.

(b) and (c). The Committee is required to go into the details of the problems faced by the small scale sector from time to time. The Committee has identified some major product groups which include engineering goods, leather manufacturers, sports goods marine products, processed food and chemicals and plastics.

(d) There are a number of agencies through whom small exporters can export their products, like the State Export Corporations, National Small Industries Corporation, State Trading Corporation, Minerals & Metals Trading Corporation, Export Houses etc.
