लेली भौर भाज वे हमारे सिटिजन नहीं है, वे इस में मदाख़लत करते हैं।

शोडा सा पीछे जायें तो खालिस्तान की मुद्रमेंट की कभी भी कोई मास-सपोर्ट नहीं मिलो, पार्टिकुतरली सिखों की सपोर्ट नहीं मिली । एक जमाना था, जब एक देश की हुक्मत खुले तौर पर इस मामले में मदद करती थी और उस वक्त पाकिस्तान के डिक्टेटर याह्या खां श्रीर हमारे हिन्दुस्तान के एक सिटिजन, जो माज हिन्द्स्तानी नहीं रहे हैं, उन के साथ मिले । 1970 में उनका गठजोड़ हुम्रा भीर उन्होंने उनकी सहायता से उस म्वमेंट को चलाने की कोशिश की । मगर श्रवाम का समर्थन नहीं मिला। बंगला देश की लड़ाइ के वक्त जब हिन्दुस्तान के जर्नेलों सामने हमारे विरोधी हथियार फेंक रहे थे, तब लाहीर के टीं 0 वी 0 श्रीर लाहोर के रेडियो से जगजीतिसह चौहान की तकरीरें करवाई जाती थीं और तस्वीरें दिखलाई जाती थीं, बार-बार उस के भाषण सूने जाते थे। ये सब याहया खां के वक्त की बातें हैं, लेकिन इन से उस मुवमेंट में कोई मान नहीं पड़ सकी ग्रौर वह ग्रकेला ही रहा। हम ने उसे हिन्दस्तान ग्राने से रोक दिया, मगर जब जनता सरकार ग्राई ग्रीर पंजाब मे सरकार के बदलने के बाद वह शख्स फिर हिन्दुस्तान आया और यहां आ कर उस ने फिर कोशिश की, हर जगह वह पहुंचा, मगर उस को कहीं भी समर्थन नहीं मिला। सिखों की पोलिटीकल पार्टी ने, जो हमारी विरोधी हैं, उन्होंने भी उस का समर्थन नहीं किया, हालांकि वह पहले उन का जनरल सेकेटरी था, जनरल सेकेटरी होते हुए शिरोमणी प्रकाली दल की तरफ से उस को हटा दिया गया। इसी तरह से जब फिर हिन्दूस्तान में कांग्रेस का राज हुआ, पंजाब में कांग्रेस का राज ग्राया, उसी दिन वह यह से

भाग गया' चला गया। आज वह यू0 के 0 में बैठा हुआ है। एक और सिटिजन जो पहले हिन्दुस्तान का था, आज वह यू0 के 0 का सिटीजन बन गया। लोग के नाडा में चले जाते हैं या दूसरे मुल्कों में चले जाते हैं। हमारे पास इस मामले में दखल देने का वहां पर कोई चैनल नहीं है। बाहर बैठे हुए सिटीजन बाहर से इस बात को चलाने की को शिश करते हैं और बहुत सा प्रेस भी इस मामले को बहुत जोर-शोर से उठाता है। कुछ ताकतें ऐसी हैं हमारे सिख भाइयों में भी, जिन को हम कह रहे हैं कि उनकी नीति बिल्कुल साफ होनी चाहिए। वह साफ नहीं हो रही है।

WRITTEN ANSWERS TO QUES-TIONS

Absorption of Census Employees

*43. SHRI R. K. MHALGI: Will the Minister of HOME AFFAIRS be pleased to lay a statement showing;

- (a) the total number of employees appointed for the purpose of carrying out the work of the census of 1981 by various State Governments;
- (b) whether it is a fact that the employees so appointed without absorbing them into various Government projects are. being threatened for the termination of their services by the State Governments; and
- (c) the directives issued by the Central Government to the State Governments in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): (a) and (b). The actual Census Operations are carried out

through the State Governments. In order to provide assistance at the District, Sub-Division and other levels, certain clerical staff was sanctioned from 1-8-1979 on a specified pattern of 1 UDC, 1 LDC and 1 Class IV official at the District level the 1 UDC or 1 LDC at Division, Tensu
levels. These posts were Municipal created by the State Governments part of their departmental hierarchy but expenditure on these posts is met by the Central Government, Appointments to these posts were made by the State Governments either by adjusting officials already in position or by fresh recruitment. Details of appointments made are not available. Since the work connected with the enumeration was to be completed within a specific period, these posts were created temporarily and cases to exist from 31-5-81. The absorption of such employees on retrenchment has to be considered by the State Government.

(c) No directives have been issued by the Central Government.

Setting up of Cold Rolling Mill Complex at Orissa

*44. SHRIMATI JAYANTI PATNALIK: Will the Minister of INDUSTRY be pleased to state:

- (a) whether his Ministry has received an application from the Industrial Promotion and Investment Corporation of Orissa Ltd. for setting up of a Cold-Rolling mill Complex at Orissa;
- (b) whether the above application is under consideration of Government;
- (c) if so, the expected time of issue of the letter of intent for opening the Cold-Rolling Mill Complex there; and
- (d) the details about the progress made so far?

THE MINISTER OF INDUSTRY AND LABOUR (SHRI NARAYAN DATT TIWARI): (a) Yes, Sir. The application was received on 13-10-1980.

(b) to (d). After careful consideration of the application, a prima-facie rejection letter was issued to the applicant on 30-12-1980 on the ground that adequate capacity had already been licensed in the proposed line of manufacture and there was no scope for creation of more capacity in this field. The application was finally rejected by the Department of Steel on 23-2-1981

Foreign Nationals Problem in Assam

*46. SHRI GHULAM RASOOL KOCHACK:

SHRI ATAL BIHARI VAJPAYEE:

Will the Minister of HOME AFFA-IRS be pleased to state:

- (a) whether Assam agitators had forwarded modified draft to the Centre on its latest proposal to solve the foreign nationals problem;
- (b) whether during the month of October, 1981 many rounds of talks were held between the Union Government and the agitators;
- (c) if so, the latest position of Assam problem;
- (d) whether any final decision has been arrived at;
- (e) whether any White Paper on the Assam dispute is being circulated;and

(f) if so, by what time?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): (a) to (d). The latest proposals of AASU/AAGSP on the foreign nationals problem in Assam were discussed with representatives of AASU/AAGSP during talks held at the official level from October 29 to Nevember 3, 1981, which ended inconclusively. The agitation leaders were invited for further talks to be held at Delhi on November 19, 1981. It was also suggested to them that if the date did not suit them another date could be fixed. However, in the meantime, they announced resumption of agitation,
