## Shortage of coking coal in Steel Plants

\*73. SHRI D. M. PUTTE GOWDA: SHRI K. LAKKAPPA:

Will the Minister of STEEL AND MINES be pleased to state:

- (a) whether Government are aware that steel plants in the country are facing acute coking coal shortage;
- (b) if so, the steel plants which are likely to be affected; and
- (c) what steps Government have taken to improve the situation?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) Yes, Sir.

- (b) All the six integrated steel plants viz. Bhilai, Rourkela, Bokaro, Durgapur, IISCO and TISCO are affected due to coking coal shortage.
- (c) The following steps have been taken to cope with the demand of coking coal:
  - (i) Close and constant liaison is being maintained with the coal supplying agencies and the Railways so as to secure maximum supplies of coking coal. Constant monitoring of the position in regard to the availability of coal is also being done at various levels through inter-ministerial consultation. Cabinet Committee on Industrial Infrastructure reviews the position regularly as as to ensure that necessary steps to improve the position are taken in the most effective and coordinated manner.

- (ii) Steps have been taken to maximise production in the captive collieries of steel plants.
- (iii) In order to supplement the indigenous supplies of coking coal, import of 1.2 MT of coking coal was arranged in 1978-79. Orders for supply of a further quantity of 0.5 million tonnes in 1979-80 have been placed and the coal has started arriving. Tenders have been received by SAIL for an additional quantity of 1 million tonnes.

# Inclusion of Tobacco, Coffee, Tea, etc. in G.S.P. Scheme of E.E.C.

- \*74. SHRI BALASAHEB VIKHE PATIL: Will the Minister of COM-MERCE be pleased to state:
- (a) whether Government have approached the European Economic Community (EEC) to include tobacco, coffee, tea and animal feed in Generalised System of Preferences Scheme; and
- (b) if so, what are further developments?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) and (b). The current status of Tobacco, Coffee, Tea and Animal feed in the GSP scheme of the European Economic Community (EEC), the initiative taken by India for the improvement of GSP treatment of these products and the results thereof are indicated below:

Unmanufactured tobacco is included in the GSP Scheme of European Economic Community. But the tariff reduction is limited and is subject to a quota. The tariff question of improvement by way further tariff reduction enlargement of quotas, particularly of Flue Cured Virginia tobacco has been taken up with the EEC in the past and some improvements secured. recent improvement is reduction of mi\_ nimum specific duty from 15 European

Units of Accounts to 13 European w.e.f. 1st Units of Account (EUA) January, 1980. Further efforts are continuing for improvements.

Coffee is already included in the GSP Scheme of EEC. However, in respect of unroasted undecaffeined coffee in which India has an export interest, the benefit of the GSP has been limited to the least developed countries. India had requested the EEC for reduction of tariff for Coffee, both on Most Favoured Nation (MFN) basis and under the GSP. The MFN undecaffeined tariff on unroasted coffee was reduced from 7 to 5 per cent w.e.f. 1st January, 1977.

Bulk tea is duty free on MFN basis. Tea in retail packs is already included in the GSP scheme with a duty free treatment.

Oil cakes which are the main animal feeds exported by India are duty free on MFN basis. Some other types of animal feed in which India has small exports are included in the EEC's GSP scheme.

### Involvement of Indian Garment Exporters in forged Certificates Racket

#### \*75. SHRI RAJNATH SONKAR SHASTRI:

#### SHRI CHHANGUR RAM:

Will the Minister of COMMERCE be pleased to state:

- (a) whether it is a fact that some Indian garment exporters are alleged to be involved in forged certificates racket;
- (b) if so, whether the Indian exporters involved in the racket have been identified, if so, details thereof stating their moduș-operandi;
- (c) the loss in foreign exchange earnings on this account; and
- (d) the steps taken by Government in the matter?

THE MINISTER OF COMMERCE MINES (SHRI AND STEEL AND PRANAB MUKHERJEE): (a) on the basis of a preliminary probe, it has come to light that some export certificates produced at the point of import in a certain quota country are doubtful authenticity.

- (b) The matter is under investigation.
- (c) It does not seem as if loss foreign exchange is involved.
- (d) Importing countries have been requested to exercise due vigilance in the matter of scrutiny of export certificates. Further, a system of monthly reconciliation of export certificates with that of import statistics maintained by the quota countries is being introduced. This is expected to considerably minimise the production of export documents of doubtful authen\_ ticity.

#### Bonus to Central Government **Employees**

- \*76. SHRI AMAR ROYPRADHAN: Will the Minister of FINANCE be pleased to state:
- (a) the number of the Central Government employees who will not get bonus under the scheme of productivity-linked bonus; and
- (b) what steps government propose to take to equalise them with those employees who will get bonus under the said scheme?

THE MINISTER OF STATE IN THE OF FINANCE MINISTRY (SHRI SAWAI SINGH SISODIA; (a) so far productivity-linked bonus has been extended to about 22 lakhs regular employees out of a total of about 32 lakhs Central Government employees.

(b) The productivity-linked bonus has been given only to encourage productivity in production oriented organisations or those which are predominantly commercial in character.
