THE MINISTER OF DEFENCE (SHRI R. VENKATARAMAN):

(a) According to reports [Pakistan is known to be vigorously pursuing its efforts both for uranium enrichment and spent fuel reprocessing capability;

- (b) Nuclear reactors like the one near Karachi produce plutonium as by-product that could be recovered on reprocessing of the spent fuel.
- (c) Government remain committeed to the plolicy of utilization of Nuclear energy for peaceful purposes.

Embezzlement alleged at Palam Cargo Office of A.E.P.C.

- (b) if so, what was the amount of money involved in the said embezzlement as shown in the audit report:
- (c) whether Government Officers nominated by the Government to the Apparels Export Promotion Council were present throughout in the meeting of the Executive Committee held on 25 January, 1982 when the report of the Statutory Auditors showing the amount of the above said embezzlement was discussed; and
- (d) whether Government would place the Report of the Audit and

the proceeding of the meeting of the above said Executive Committee on the Table of the House, if so. when?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI SHIVRAJ V. PATIL): (a) and (b). An investigation into the accounts of the AEPC Office in the Cargo Complex of the Palam Air Port, carried out by the Auditors of the AEPC in Aug-Sept. 1981, revealed that an amount of Rs. 59,419 was short deposited in the bank out of Council charges received in cash from 1st Jan., 1981 to 31st July, 1981. Out of the said amount, a sum of Rs. 2180 was recovered and deposited in the bank.
