Fund amount to a little over Rs. 82 lakhs as shown below:—

- 3. Steps taken/being taken to augment the resources of the National Children's Fund are:—
 - (i) Soliciting donations from public undertakings, Business/Mercantile Houses:
- (ii) Approaching Indian residents abroad through Missions;
 - (iii) Installation of donation boxes at the Headquarters and the Regional Field Units of the National Institute of Public Cooperation and Child Development;
 - (iv) Collections from public including schools;
 - (v) Printing and sale of greeting cards with special references to International Year of the Disabled Persons:
- (vi) Continued sale of International Year of the Child seals up to 31 December, 1981.
- 4. Donations to the National Children's Fund presently qualify for 50 per cent exemption from Income Tax in the hands of donors.
- 5. So far no financial assistance has been released to any voluntary organisation from the National Children's Fund However, proposals from voluntary organisations are under consideration for assistance from the National Children's Fund.

Decreasing Trend in Breast-Feeding

- in the country and that too specially among the urban elite;

- (c) whether Government propose to set up laboratories in each State to provide more facilities of chemical analysis of baby-food?

THE MINISTER OF STATE IN THE MINISTRIES OF HEALTH AND FAMILY WELFARE (SHRI NIHAR RANJAN LASKAR): (a) and (b) Yes, Sir.

(c) All States except Meghalaya, Manipur and Sikkim have established laboratories for chemical analysis of foods, including baby foods. Amongst Union Territories Delhi, Pondicherry and Goa, Daman & Diu have established laboratories. Union Territory of Andaman & Nicobar has initiated action for establishing a food laboratory.

Bookstalls at Stations

*285. SHRI KAMLA MISHRA MADHUKAR: Will the Minister of RAILWAYS be pleased to refer to the reply given to unstarred Question No. 3692 dated 10-9-81 regarding Bookstalls for unemployed graduates and state:

(a) whether it is fact that two Private Ltd. Companies, A.H. Wheeler and M. Gulab Singh & Sons are holding a large number of Bookstalls on the big and medium stations and the policy of holding five Bookstalls does not apply on them;

- (b) if so, what are the reasons thereof;
- (c) whether it is a fact that the Ministry of Railways have not curtailed the holdings of Bookstalls of the above two contractors during the period 1973 to 1981 for the sake of unemployed graduate persons;
- (d) if not, what are the reasons thereof?

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS AND EDUCATION AND SOCIAL WEL-FARE AND IN THE DEPARTMENT **AFFAIRS** PARLIAMENTARY (SHRI MALLIKARJUN): (a) (b) The three major bookstall contractors on Railways, viz. Wheeler & Co. (P) Ltd. Mis. Higginbothem (P) Ltd., and M/s. Gulab Singh & Sons (P) Ltd., were allotted the bookstall contracts under the old policy of allotting these contracts to established and reported book-sellers. Out of 840 stations, where bookstall facilities have been provided. these three contractors are holding contracts at 268, 48 and 17 stations respectively. There has been no increase in their holdings after 1964. As explained earlier in reply to unstarred Question No. 3692 on 10-9-81 and Unstarred Question No. 9330 on 30-4-81, there is no ceiling limit on bookstalls except that for alloting tional bookstalls to the contractors already holding five or more bookstalls, other than the Cooperatives/ Associations of Unemployed graduates and the Cooperatives of Actual Workers Vendors of the bookstalls. prior permission from the Ministry of Railways is required to be obtained by the Zonal Railways.

(c) and (d) At the suggestion of the Ministry, M/s. A.H. Wheeler & Co. and M/s. Gulab Singh & Sons surrendered their bookstalls at 25 and 1 stations respectively for allotment to unemployed graduates pursuant to the adoption of new policy in 1973 reserving all future allot-

ments in favour of the unemployed graduates
