## Shortfall in resources of term-lending Institutions

\*300. SHRI BHIKU RAM JAIN: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that the term-lending institutions are facing a short-fall in the resources support provided by Government;

(b) the estimated resources support needed by these institutions during the current Financial Year; and

(c) the amount expected by them during the same period?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE MAGANBHAI (SHRI BAROT): (a) to (c). At the time of preparation of the Annual Plan 1981-82. the term lending institutions viz. Industrial Development Bank of India, Indystrial Finance Corporation of India, Industrial Credit and Investment Corporation of India and Industrial Reconstruction - Corporation of India had projected a total requirement of funds of .Rs. 2134.23 crores for the year 1981-22. This estimate was based on the experience of the institutions regarding the growth in disbursements and their perception about the future increase of assistance required in the light of plan targets. A sum of Rs. 1750.23 crores is already available to the institutions from the Central budget, market borrowing allocations, borrowings from the Reserve Bank of India's National Interest Credit (LTO) Fund and their internal resources. The need for providing further funds to the institutions to meet their projected requirements in the course of the year has been recognised. They have been assured of adequate funds in order to maintain the tempo of industrial growth particularly in areas to which Government attaches greater priority.
