THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHAN-KARANAND): (a) to (c). Appraisal and evaluation of the programme is an integral part of the Family Welfare Programme which is done from time to time. Acceptance rate in rural areas has been traditionally lower than in urban areas. However, there has been marked improvement in this position over the last two years.

Apart from intensifying efforts to spread awareness and information about the small family concept, the Village Health Guides Scheme has been revamped with a view to bring such knowledge and information as well as services and supplies for nonclinical methods at peoples' doorsteps. As a strategy, it has also been decided to take a selective area-specific approach in different areas.

## Non-Formal Education through Voluntary Agencies

### Bilateral Trade Relations with Japan

(a) whether it is a fact that Japan has expressed the need for development of political and bilateral trade relations with India besides the present economic cooperation; and

(b) if so, details thereof and reaction of the Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a) and (b). In recent high level meetings with Japan; both sides have expressed the desire to improve relations and welcomed the new developments in collaborative economic relations between them.

#### Underutilisation of Wagons

## \*176. SHRI DAULAT RAM SARAN : SHRI S. M. KRISHNA:

Will the Minister of RAILWAYS be pleased to state:

(a) whether it is a fact that during the last few months there have been no takers for rail wagons and that there has been gross underutilisation of the wagons on broad gauge and metre gauge; and

(b) if so, details thereof stating the reasons for the shortfall in the demand of rail wagons and the extent of loss suffered by the Government as a result thereof?

THE MINISTER OF RAILWAYS (SHRI A. B. A. GHANI KHAN CHOU-DHURY): (a) No Sir. However, there was shortfall in the demand of wagons during the monsoon months. Demand has, however, picked up during the current month.

(b) The daily loading of wagons was ranging between 26500 and 27000 from April 1982 to July 1982. On Broad Gauge, it came down to 25660 wagons in August, 1982. In September, it improved to 26594 (estimated). From the present trend in October, it is expected to be 26485 wagons.

On Metre Gauge, loading came down to 4590 wagons in August compared to the trend of 4700 to 5000 wagons per day in earlier months. In September, it increased to 4919 wagons (estimated) daily.

The main reason for less loading was less offer of traffic by the principal users of rail transport. However, every single month of the productivity year has witnessed record loading compared to individual months of the past year.

It is not possible to quantify the losses that occur only on account of fall in demand of traffic. However, revenue earnings in the current financial year have shown a substantial improvement over the record earnings of the previous years.

## Commissions to look into University and School Teachers
