(d) and (e). Export quota for HPS Groundnuts has to be determined keeping in view factors like domestic production, availability, internal and international prices, the likely effect of exports on the domestic market etc. For 1980-81, a quota of 50,000 tonnes was released for export. The question of release of an additional quota was considered and the decision was not to allow any additional quota.

The quota for 1981-82 has yet to be determined.

Accident in Bokaro Steel Plant

- *1122. SHRI A. K. ROY: Will the Minister of STEEL AND MINES be pleased to state:
- (a) whether it is a fact that no trade union or people's representative has been kept in the Committee appointed to probe into the accident in the Bokaro Steel Plant in March, 1981 killing nine people;
- (b) whether it is a fact that no time limit has been fixed for completing the enquiry and no action has been taken against any officer;
- (c) whether it is a fact that most of the Trade Unions have questioned the credibility and effectiveness of such Departmental probe considering the seriousness of the incident; and
 - (d) if so, steps taken thereon?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) Yes, Sir.

- (b) No, Sir. The committee was required to submit its report as early as possible but not later than the 30th April, 1981. However, in a request received from the committee, they have been permitted to submit the report by the 11th May, 1981. The question of taking action against any officer will arise only after Government has considered the report.
- (c) Bokaro Steel Plant has not received any representation from Trade Unions questioning the credibility and effectiveness of the committee constituted.
 - (d) Does not arise.
