- (a) Whether it is a fact that the Jammu & Kashmir State Government had been protesting to the Central Government for short supply of foodgrains by the Food Corporation of India to the State:
- (b) if so, the total amount of foodgrains i. e., rice and wheat separatly supplied-by the F. C. I. to J & K State till 31 October, 1983 and in the corresponding period last year, separately; and
- (c) Whether Government will place on the Table on the House the factual position of the situation?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI BHAGWAT JHA AZAD): (a) No, Sir. Food Corporation of India has been supplying foodgrains to the Government of Jammu and Kashmir on the basis of allocations issued by the Government of India.

(b) and (c) A statement indicating quantities of wheat and rice supplied by the Food Corporation of India to the State Government during January, 1983 to October, 1983 and the corresponding period last year is laid on the Table of the Sabha.

Investigation Into Adulteration of vanaspati With beef Tallow

SHRI ANANDA PATHAK: Will the Minister of FOOD AND CIVIL SUPP-LIES be pleased to state:

- (a) whether Government have conducted any investigation regarding adulteration of Vanaspati with beef tallow at the production stage;
- (b) if so, particulars of the persons who actually conducted the said investigation;
- (c) details regarding their expertise on the said job with details of their past experience, if any;
- (d) when the said investigation had actually taken place, and
- (e) names of the production units where such investigation was conducted?

THE MINISTER OF STATE OF THE MINISTRY FOOD AND CIVIL SUPPLIES (SHRI BHAGWAT JHA AZAD): (a) Yes, Sir.

(b) at (c) Officers of the Directorate of Vanaspati, Vegetable Oils and Fats under the Department of Civil Supplies and its Zonal Inspectors have been conducting regular inspections in the 92 licensed vanaspati manufacturing factories in the country. These officers and the field staff are fully qualified personnel in Oil Technology or M. Sc. They have long years of experience in this field, in many cases even more than 15 years.

- (d) The field staff as well as the officers of the Directorate at the Headquaters carry out surprise inspections of the factories, draw samples regularly for analysis in the well-equiped modern laboratory of the Directorate to ansure that the product conforms to the specifications laid down by the Government. During the period 1.1.83 to 31.10.83, as many as 746 inspections were carried out and in all 3964 samples were drawn and analysed. The analysis of the samples drawn has not shown the presence of beef tallow in any one of them so far.
- (e) A complete list of the vanaspati units where the surprise inspections are carried out regularly is enclosed at statement I.
