(a) It is a fact that supply of coal to certain sectors during the years has been less than demand; apart from low production of certain types of coal, transportation of coal has been another impediment in the adequate supply of coal in spite of reasonable ground stocks.

(b) Statement of the measures adopted to increase coal production is laid on the Table of House.

(c) During the year 1979-80 the Government had sanctioned 18 major projects at a cost of 314 crores to produce when fully completed 22.82 million tonnes of coal by the mines in Coal India Ltd. Apart from this Government have also sanctioned 7 projects

for advance action at a cost of 54 crores to produce 4.27 million tonnes of coal in Singareni Collieries Company Ltd.
