Sugar Technological Institute

1565. **Shri Assar:** Will the Minister of Food and Agriculture be pleased to state:

(a) whether it is a fact that there is a demand for setting up of a Sugar Technological Institute in Maharashtra region in Bombay State to advise sugar industry which is expanding in Maharashtra; and

(b) if so, whether there is any proposal before Government to establish such an Institute?

The Minister of Transport and Communications and Food and Agriculture (Shri S. K. Patil): (a) and (b). The need for setting up a Sugar Technological Institute in Maharashtra region was mentioned by the President of the Deccan Sugar Technologists' Association in their speeches at the 12th and 13th Annual Conventions of the Association. However, no such proposal is at present under consideration by the Government.

Ex-employees of Cash Contractors

1567. **Shrimati Sucheta Kripalani:** Will the Minister of Railways be pleased to refer to the reply given to Unstarred Question No. 1633 on the 9th March 1959 and state:

(a) the number of ex-employees of cash contractors taken by Northern Railway who have since retired and are claimants for gratuity from Government;

(b) how many of them have been considered eligible for payment of gratuity and actually paid;

(c) how many cases are pending at present; and

(d) how long will it take finalise them?

The Deputy Minister of Railways (Shri Shahnawaz Khan): (a) 36.

(b) 33 considered eligible cases, 3 being still under examination. Payment has actually been made in one case.

(c) 32.

(d) 18 cases will be finalised in about a week. 5 more cases will take a little longer time. 9 cases are under further examination and it is difficult to say precisely when these will be finalised.
