CORRECTION OF ANSWER TO STARRED QUESTION NO. 148

The Deputy Minister of Railways (Shri S. V. Ramaswamy); Sir. a supplementary question asked by Shri V. C. Shukla on 16th August, 1958 and reply thereto, arising out of Starred Question No. 148 may have given the impression that only 12 lakhs of wooden sleepers were being purchased by the Railways from abroad as against 20 lakhs originally contemplated. I wish to clarify the position. The figure of 12 lakhs (actually 12.1 lakhs) refers only to Broad Gauge sleepers and if 7.91 lakhs of Metre Gauge sleepers are also taken into account the total number of sleepers ordered abroad would come to 20 lakhs.
