# Delhi Central Jail

2146. Shri Kunhan: Will the Minister of Home Affairs be pleased to state:

# Practice Firing in Jhansi

2147. Shri Kunhan: Will the Minister of Defence be pleased to state

(a) whether it is a fact that on the 26th March, 1960 two persons were injured by a bullet which hit them in the course of practice firing in Military field at Nagada in District Jhansi (U.P.);

(b) whether one of the injured died in the hospital; and

(c) whether any compensation is being paid to the members of the family of the deceased woman and injured man?

The Minister of Defence (Shri Krishna Menon): (a) and (b). Yes, Sir. On the 26th March, 1960 two persons were injured by an artillery shell which fell near the village of Nagda during firing practices. Prior to the commencement of firing, the villagers had been warned about the firing practices on that date and a certificate to the effect that the ranges were clear was given by the local civil authorities. The injured persons were evacuated to the Military hospital at Jhansi for treatment, where one of them, a woman, succmbed to her injuries the same night.

(c) A Court of Inquiry has been constituted. The question of compensation will be considered after the proceedings of the Court of Inquiry on the accident are received. 12 hrs.
