(PROF. SHER SINGH): (a) A task Force has been constituted by the Steering Group set up by the Planning Commission to look into the various aspects of sugar industry for the 5th Plna.

(b) The Task Force no sugar has already submitted its report to the Steering Group in March, 1973. The report covers the present status of the sugar Industry lines of development of sugar industry during the Fifth Plan, likely difficulties in achieving the target aimed at and solutions therefor, development of raw material like sugarcane and sugar beet, better utilisation by-products and bringing about cost reduction etc.
