Bill was to raise the minimum from 4 per cent to 8-1/3 per cent. On that Bill, while intervening, I gave an assurance that I will see the entire bonus scheme is reviewed and the bonus scheme, as it is applicable todaythe terms of reference are there-will be reviewed (Interruption)

PROF MADHU DANDAVATE would like to know from the hon Minister whether it is true that a number of central trade union organisations have already demanded that the Bonus Act should apply to insurance and a number of transport industries also and it so, what is the reaction or the Government thereto

SHRIR K KHADILKAR It is true the central trade union organisations, time and again, are making such demands will be kept in view when the review is taking place and the scheme is incorporated m the Bonus Act

- (a) whether food stocks neld by the International Red Cross were handed over to India for distribution in Bangladesh, and
- (b) whether International Red Cross is distributing supplies through the agency of Indian Red Cross '

THL DEPUTY MINISTIR IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAI SINGH) (a) No The food stocks held by the listernational Red Cross which were handed over to the Indian Red Cross were meant for distribution amongst the Bangladesh refugees in India After the return of the refugees to Bangladesh, the surplus of these food stocks was transferred by the Indian Red Cross to the Bangladesh Red Cross Society for distribution in Bangladesh

(b) No Sir The International Red Cross is not distributing supplies in Bangladesh through the agency of the Indian Red

SHRI RAGHUNANDAN LAL BHATIA: There are comments in the British press with regard to the Indian Red Cross assuming the role of distributing food and supplies left over in India The hon Minister has said that they have no stocks or, whatever stock there were. they have been handed over to the Bangladesh Red Cross Society May I know if they are acting as agents of the International Red Cross in Bangladesh or any officer has been appointed to assist them?

SHRI SURENDRA PAL SINGH I have already clarified the position with regard to the stocks which were left with the Indian Red Cross The stocks have been hanged over to the Bangladesh Red Cross Society As far as the criticism in the British press is concerned that criticism was directed against the Bingladesh Government for not making adequate arrangements for providing supplies to non Bengalis. Our information is that adequate an ingements were made by the Bangladesh Government and that even now they are making every effort to send supplies to Biharis in Bangladesh. These reports are uniustified

SHRI RAGHUNANDAN LAL BHA-IIA He has not replied to my question I wanted to know whether we have sent some officer to assist them in the distribution of food stocks in Bangladesh

SHRI SURENDRA PAL SINGH Yes. Sir We have received a request from the Bangladesh Government and the Bangladesh Red Cross Society for sending one or two officers from India This matter is getting our immediate attention and, I think a decision has been taken to send some officers to Bangladesh shortly
