SHRI B. K. DASCHOWDHURY: I could not follow the reply, Sir. I wanted to know the price.

MR. SPLAKER: No foreign exchange has been allowed to the party so far. So far as the price is concerned, unless the prototype is produced, they will not be in a position to give the other details.

SHRI B K DASCHOWDHURY I would like to know whether the Ministry has received a study report from the National Council of Applied Feonomic Research regarding seconter manufacture in which they have said that, if prices go up, whatever may be the total production, the demand will fall down. In view of this, May I know whether the Ministry has considered fixing up any particular price, as far as possible, whoever may be the scooter manufacturers?

SHRI SIDDHESHWAR PRASAD: The prices of different scooters which are available in the market are: Bajaj Rs 2,434; Lambretta Rs. 2,425; Fantabulous, self starter, Rs 3, 200; Rajdoot Rs. 3,275.

SIIRI B K. DASCHOWDHURY: I want to know whether steps have been taken by the Ministry so that prices may not go up. If the prices go up, the demand will fall down. That was said by the National Council of Applied Economic Research.

MR. SPEAKER: He has given the prices of those which are already produced.

- (b) It has enabled reasonable step-up in the Plan outlays and also helped in further activising the economy.
- (c) The excess demand situation no doubt aggravated the pressure on prices but this could not be regarded as too much considering the inevitable increases in defence expenditure, expenditure on refugees from Bangla Desh, relief for natural calamities and the much needed step-up in the Plan outlays. To moderate the effect of deficit financing on prices and the general economic situation, the Government has taken a number of measures like strict regulation of credit, continuance of physical controls, strengthening of the public distribution system, building up of buffer stocks, suspension of forward trading in gur and certain oilseeds and edible

oils, reliance on non-inflationary methods of resource mobilisation and stricter control on overdrafts

Whave adopted a system whereby we can recover the overdrifts already taken by the State Covernments and during 1972-73 we shall be hiving a receive to the tune of Rs. 67 crores and the reby the delicit finance will come to the tune of Rs. 175 crores as was explained by the hon. Finance Minister.

SHRI MOHAN DHARIA ' I entirely agree that I have montioned regarding over-drafts already taken by the State Governments.

MR. SPEAKER: That fully justifies his asking that question.

SHRI MOHAN DHARIA: I have not got that information regarding State-wise over-drafts to-day.

MR. SPEAKER: You may supply the information to the hon Member.

SHRI JYOTIRMOY BOSU: Will the hon. Minister kindly tell us, if he is able to, as to, out of the total allocation for the Fourth Plan, how much roughly is oriented for increase in generation of basic wealth or GNP?

SHRI MOHAN DHARIA: Sir, I may say, it is very difficult to bifurcate how much is to be devoted for the generation of wealth. But, as I have said carlier on, whenever any recourse is taken for deficit financing, if the national wealth or national income is not commensurate with that deficit financing, it certainly adds in creating the inflationary trends in the country...

SHRI JYOTIRMOY BOSU: That is what you have done in the past.

SHRI MOHAN DHARIA: That is why you may see in the Central Budget of this year that all possible measures are being taken to see that deficit financing is brought down lower and lower, and it is the reason why we have brought this down to the tune of Rs. 240 crores this year.

SHRI JYOTIRMOY BOSU: May I say that as a Member of the Unemployment Committee we visited West Bengal and we asked the Financial Commissioner, out of the total fourth plan allocation for West Bengal, how much is to be spent in increasing the GNP. How said, 'very little'.

MR. SPEAKER: Mr. Jyotirmoy Bosu, that is not a very healthy practice. You bring in some personal knowledge and ask a question. That is not asking a question. It is only confirmation of something.

SHRI C.T. DHANDAPANI: What is the formula adopted by the Planning Commission in the matter of making allocation of funds? Is it on the basis of population or on the basis of backwardness of the State? The Minister may come forward and say, it is based on the basis of population and the backwardness of the State. But, at the same time, Sir, I would like to draw the attention of the hon Minister to the fact that for the year 1970-71, the Planning Commission had allocated Rs. 803 crores to the several States. But, at the same time, some forward States got more funds...

MR. SPEAKER: Are you asking a question or giving the information yourself? Please don't do it; ask a straight question.

SHRI C. T. DHANDAPANI: On what basis is the Planning Commission making these allocations? I would like to know that.

SHRI MOHAN DHARIA: I am afraid this is not relevant to the main question, Sir. But, I may say, that it is on the basis of the recommendations made by the National Development Council, that these allocations regarding Central assistance to State Governments are made.

SHRI C. T. DHANDAPANI: What are those recommendations?

MR. SPEAKER: Letter on. Not out of this; not arising out of this question.
