Schemes to Revise Canalisation of various Articles through S.T.C.

*445. SHRI S. M. BANERJEE: Will the Minister of COMMERCE be pleased to state:

- (a) whether there is a scheme to revise the canalisation of various articles through State Trading Corporation; and
- (b) if so, the salient features of the scheme?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI A. C. GEORGE): (a) and (b). It is Government's policy to canalise imports progressively through public sector agencies. To this end the list of items is reviewed every year.

Constitution of Committee of Bankers by Reserve Bank of India

*448. SHRI D. B. CHANDRA GOWDA: Will the Minister of FINANCE be pleased to state:

- (a) whether the Reserve Bank of India has constituted a Committee of Bankers to ensure inter alia equitable distribution of food procurement credit among the Commercial Banks participating in consortium arrangements to finance the operations of the Food Corporation of India, State Governments and their agencies for procurement, storage and distribution of food-grains; and
- (b) if so, the terms of appointment and functions of the Committee?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRIMATI SUSHILA ROHATGI): (a) Yes, Sir.

(b) The Reserve Bank of India constituted a Committee of Bankers in December 1972, comprising representatives from Reserve Bank of India, State Bank of India, Central Bank of India, Punjab National Bank, Bank of India and Bank of Baroda. This Committee was constituted for ensuring equitable distribution of food procurement credit among the commercial banks participating in the consortium arrangement introduced by the Reserve Bank of India to finance the operations of the Food Corporation of India. State Governments and their agencies for proceurement, storage and distribution of foodgrains and also to assess the credit needs of these agencies. The Committee will also be looking into various procedural and other operational aspects relating to the consortium arrangement.

Opening of Evening Branches of State Bank of India and Nationalised Banks

- (a) whether there are any Evening Branches of the State Bank of India or of any Nationalised Bank, in the country;
- (b) if so, the names of these Branches, their locations and the dates of their opening; and
