(a) whether Government's attention has been drawn to the reported imbalances in the power supplied to rural areas in the country; and

(b) if so, the remedial measured proposed?

THE MINISTER OF ENERGY (SHRI K C PANT); (a) and (b). Power supply to rural areas for irrigation, agriculture and agro-based industries is receiving a high priority in allocation of resources and allocation of energy in case of shortages. The oil crisis has further brought home the necessity of intensifying efforts for rural electrification to replace use of dissel for pumping etc. All steps are being taken to reduce the imbalance between the rural and urban economy

## Cancellation of Press Accredition of Journalist<sub>g</sub>

THE MINISTER OF STATE OF INFORMATION AND BROADCAST-VIDYA CHARAN ING (SHRI SHUKLA): (a) to (c). According to existing rules for accreditation of correspondents, the list of accredited representatives is subject to review in consultation with the Central Press Accreditation Committee. The list was accordingly reviewed on the 14th February, 1976 in a mecting of recently reconstituted committee. Since the recommendations of the committee are of a confidential nature, they cannot be disclosed in public interest.

## Increase in Juvenile Crime in the Country

Will the Minister of HOME AFFAIRS be pleased to state

(a) whether Government are aware that juvenile crime in the country is increasing; and

(b) if so, the reasons therefor and the reaction of Government thereto?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN); (a) and (b) Government are aware of the increase in juvenile crime in the country. The increase is attributable to the rise in general crime as a result of rise in population and increase in number of regulatory laws and a host of socioeconomic factors. Government fully share the concern of the Hon'ble Mem bers over the increasing trend in juvenile crime. Various social welfare measures are being taken by the States to check juvenile delinquency. The Central Government, in the Department of Social Welfare are in close touch with the State Governments and coordinating these efforts.
