Plan for production of drugs in Indigenous Sector

*114. SHRI VASANT SATHE: SHRI DHAMANKAR

Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

- (a) whether any plan for production of vital drugs in consultation with the indigenous sector of the drug industry is being worked out so as to meet the 5th plan targets for drujs and pharmaceuticals;
- (b) whether any steps are being taken through expansion of indigenous chemical industry to minimise our dependence on foreign suppliers for vital life saving drugs, basic and intermediate chemicals and thus help the rural population; and
- (c) whether any time-bound national drug development programme is contemplated so as to step up production and take the medicines to a large percentage of our rural population?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRIK R GANESH): (a) to (c) According to the draft Fifth Five Year Plan, the drugs turnover in the country would increase to Rs. 500 crores per annum by 1978-79. This would involve production of Rs. 150 to Rs 200 crores of bulk drugs. In the context of the approach to the Fifth Five Year Plan and with a view to step up production, Government in its industrial licensing policy of 1973 consolidated the core dustries of importance to the national economy. Industries having direct linkage with such industries and industries with long term export potential have been identified as of basic, critical and of strategic importance for the growth of the economy have been included in Appendix I of the said policy. Drugs and Pharmaceutical Industry is one of the industries included in Appendix I. For the production of vital drugs, the draft plan also makes provision for expansion of the role of the Public Sector.

Government have appointed a Committee on Drugs and Pharmaceuticals Industry under the Chairmanship of Shri Jaisukhlai Hath; and the terms of reference of this Committee inter alia include: --

"To recommend measures necessary for ensuring that the Sector attains a leadership role in the manufacture of basic drugs and formulations, and in research and development".

"To make recommendations promoting the rapid growth of the drugs industry and particularly the Indian and small scale industries sector. In making its recommendation the committee will keep in view the need for a balanced regional dispersal of the industry"

The Committee is expected to submit its report by April, 1975. It has furnished to Government a list of essential drugs and common house-hold medicines which will be required to be manufactured in large quantities The details are being worked cut for ensuring adequate production. Discussions have been held with the representatives of Indian Medical Association and the Indian Drug Manufacturers Association regarding the role which the indigenous sector of the drug industry should play in making available drugs in adequate quantities to meet the requirements Country, The Indian Sector has agreed to submit a blue print shortly. This sector has also been asked to prepare a scheme for production of mass consumption drugs at cheap prices and to identify such drugs out of the list of the Hathi Committee. Further conwith them will follow to sultation draw up time bound programme of production expansion of such drugs.
