Government of Maharashtra have been discussing with Reserve Bank of India and Government of India the credit facilities to be provided for the operation of the Cotton Monopoly Procurement Scheme during 1975-76. For the year 1975-76, RBI has sanctioned a credit limit of Rs. 20 crores to the MSCB for financing Monopoly Procurement Scheme and has also permitted it to finance the scheme upto a further limit of Rs. 20 crores out of its own resources.

To enable the MSCMF to tide over temporary financial difficulties, commercial banks have also sanctioned a credit limit of Rs. 18 crores to the Federation upto 31st January, 1976 besides a packing credit limit for export of cotton upto a maximum of Rs. 15 crores till 31st March, 1976.

Maharashtra Cotton Monopoly Procurement Scheme being a State Scheme its implementation is the responsibility of the State Government. Since the scheme is implemented through a cooperative agency, the credit support has to be mainly from the cooperative system. Having regard to the resources of commercial banks and competing demands on them, the assistance from commercial banks to the scheme of this type can at best be only of a marginal character.

Foreign Exchange Earnings from Tourists

*252. SHRIMATI SAVITRI SHYAM: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI SURENDRA PAL SINGH): (a) The foreign exchange earnings from tourism during July—December, 1975 on the basis of current price levels is estimated at Rs. 56.5 crores. This is exclusive of the foreign exchange revenue earned by Air India and Indian Airlines on payment of fares by international passengers.

(b) The provision of tourist facilities is a continuous process. The emphasis in the Central Sector has been on the building up of tourist infrastructure (accommodation and transport), provision of recreational, entertainment and sight-seeing facilities and production of tourist literature. For this purpose, an outlay of Rs. 78 crores has been provided in the Central Sector.
