Recruitment Requirements of Defence Public Sector Undertakings

56. SHRI SAKTI KUMAR SAR-KAR: SHRI S. M. SIDDAYYA:

Will the Minister of DEFENCE be pleased to state:

- (a) whether various Defence Public Sector Undertakings have been advised to project their recruitment requirements annually to the Placement Officers in the I.I.Ts. and o her training institutions concerned, in order assist in improving the reruitment from amongst the Scheduled Castes and Scheduled Tribes to technical posts reserved for them in these Undertakings:
- (b) whether these Undertakings also contact the Placement Officers in the various technical institutions, and
- (c) if so, since when this practice is being followed and with what concrete results?

THE MINISTER OF STATE (DEF-ENCE PRODUCTION) IN THE MINIS-TRY OF DEFENCE (SHRI RAM NIWAS MIRDHA): (a) Yes Sir. Advice to this effect was given to Defence public sector undertakings in July, 1972.

(b) and (c). Although these undertakings are notifying their reserved vacancies for Scheduled Castes and Scheduled Tribes to various agencies prescribed in the Presidential Directives issued to them on this subject, the assistance of Placement Officers in the Institutes of Technology does not appear to have been availed of them for one reason or the other. They are again being advised to invariably project their requirements of technical posts to the Placement Officers in the Indian Institutes of Technology and other training institutions as and when there is requirement of filling up such technical posts.

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether according to an English Newspaper dated the 17th October, 1974, the State Council of Portugal has adopted a law which removes from the Portuguese Constitution any mention of "Portuguese India": and
- (b) whether this will help to restore better relations between the two countries?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI YESHWANTRAO CHAVAN): (a) The Government of Portugal has published a decree authorising the President of Portugal to conclude an agreement with India recognising India's full sovereignty over former Portuguese territories in India.
