- (b) if so, Government's reaction thereto; and
- (c) total remittances by foreigncontrolled drug firms operating in India, year-wise, during the last three vears?

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI); (a) Yes, Sir.

- (b) The activities of the foreign companies in India are regulated under the provisions of Foreign Exchange Regulation Act, 1973 and also the guidelines issued to administer Section 29 of the said Act.
- (c) Details of remittances made by the foreign drug firm during 1971/ 1971-72 and 1972/1972-73 are contained in Annexure V to Chapter V of the Report of Committee on Drugs and Pharmaceutical Industry, a copy of which was laid on the Table of the House on 8th May, 1975.

Development of Project Consultancy in Fertilizers and Chemicals

- (a) whether the Fertilizer Corporation of India has developed project consultancy capacity in fertilizers and chemicals; and
- (b) whether F.C.I. is trying to sell this consultancy in markets in West Asia and South-East Asia?

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI); (a) and (b). The Corporation has developed the necessary expertise in regard to the offer technical consultancy services in the field of fertilizers and allied chemi-The Corporation has already conducted techno-economic feasibility and other studies in connection with the setting of fertilizer plants in some of the Gulf countries. Bangladesh and in the Philippines and is in a position to take up similar jobs elsewhere.
