The gentleman asking the Question gets two chances just after the main Question. He does not participate later on.

SHRI VAYALAR RAVI : Will the Government circulate the report to get the opinion of the students from various Universities? The Commission has recommended students' participation only in the Punishment Courts. I would like to know whether they will give representation to them in the administrative matters also.

So, will Government circulate the report for discussion and recommendation by the university students' unions?

SHRI SIDDHARTHA SHANKAR RAY: The report is published and it is not very expensive. But so far as the views of the students are concerned, we shall try to ascertain them in some proper form It will however not be possible for Government to send copies of the report to each and every one of the various college unions.

SOME HON, MEMBERS rose-

MR. SPEAKER: So many questions have already been asked on this matter. Why not pass on the next question?

SHRI S. M. BANERJEE: I have already established my claim, Sir. I have a very good question to ask.

MR SPEAKER: The fact that it may be a very good question does not mean that we should not pass on to the next question.

SHRI NAWAL KISHORE SINHA: There are points which arose from the answer of the hon. Minister and which need to be clarified.

MR SPEAKER: There is no question of clarifications now. I am passing on to the next question.

SHRIMATI JYOTSNA CHANDA: I find from the statement that 102 plants and factories are going to be established in the country. May I know whether three factories which are going to be established in Assam will be established in the Fourth Plan?

PROF. SHER SINGH: We have licensed for three factories in Assam in the Fourth Plan period, and we hope that these will be established in the Fourth Plan period itself.

SHRIMATI JYOTSNA CHANDA: May I know whether these factories which are going to be established in Assam would go into production within five years, and whe'her they would be able to feed the whole of Assam?

PROF. SHER SINGH: It is not possible for me to say. It depends upon the gentlemen who will stait these factories. We have recently given these licences, and it is for them to start these factories, and it depends upon them whether they will begin production within five years. As for self-sufficiency for Assam, it is difficult to say, because that will depend upon the quantum of production from these factories.

SHRI K. S. CHADVA: Keeping in view the fact that there is a shortage of groundnut oil in the country, I would like to know whether Government intend to...

MR. SPEAKER: I have not called the hon. Member...

SHRI S. M. BANERJEE: I would like to know who asked him to put his question.

SHRI ATAL BIHARI VAJPAYEE: Sir, this is a reflection. You have allowed him.

MR. SPEAKER: He does not give me a chance to speak. What I can do?

SHRI K. S CHAVDA: In view of the shortage of groundnut oil in the country, may I know whether Government intend to put a ban on the use of groundnut oil by the factories producing vegetable oil?

PROF. SHER SINGH: We have no intention to put a ban on the use of groundnut oil directly by those who take vegetable oils. We cannot stop all these people from using groundnut oil. I know that there is a dearth of groundnut oil in the country, and we are supplementing it wherever necessary by soyabean oil for Vanaspati factories.

श्री पन्नालाल बारूपाल: मैं जानना चाहता हूँ राजस्थान के जिला गंगा नगर में क्या कोई वनस्पति तेल का कारखाना लगाने की योजना है ?

प्रो० शेर सिंह: I require notice for this. वैसे राजस्थान में 9 कारखाने खुळने है, उन में से गंगानगर में कोई खुळने वाला है या नहीं, मैं इस वक्त नहीं कह सकता।
