(b) if so, how far these impediment stood in the way of re-opening of the talks for resumption of postal and tele-communication links and travel facilities?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AF-FAIRS (SHRI SURENDRA PAL SINGH): (a) and (b). Pakistan had unilaterally postponed the June nieeting for discussing resumption of postal, telecommunication links and travel under the Simla Agreement. Pakistan's excuse that India's peaceful nuclear experiment has vitiated the atmosphere and therefore assurance or guarantee was needed before talks are resumed is quite untenable. India has continued to observe the Simla Agreement in letter and spirit and the Agreement contains all the assurances necessary. Pakistan should realise that implementation of normalisation measures is in her own interest.

Will the Minister of EXTERNAL AFFAIRS
be pleased to state:

- (a) whether some West German experts have recently visited India to render assistance in certain specific fields; and
- (b) if so, in what spheres West German help has been sought by his Ministry?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AF-FAIRS (SHRI SURENDRA PAL SINGH): (a) Yes, Sir.

(b) The Ministry of External Affairs itself has not sought any technical assistance from the Federal Republic of Germany. Other Ministries of the Government of India, however, have done so in the fields of agriculture, Television, Small Scale Industry, Technical Education, Export Promotion, Printing Presses, Toolrooms, and Science and Technology.

SHRI SAKTI KUMAR SARKAR: May I know from the hon. Minister what is the exact number of experts who recently visited India, who are the experts and what are the subjects of expertise?

SHRI SURENDRA PAL SINGH: I have not got the names of all the experts who recently visited India. But as on 1st July, 1974, there are about 53 technicians in India.

SHRI KUMAR MAJHI: After the underground nuclear explosion in the Rajasthan desert, the people have got the confidence in the Government that India also has got the technical know-how. But how is the External Affairs Minister justifying the technical assistance sought for by various Ministries from foreign countries?

SHRI SURENDRA PAL SINGH: The level of technical know-how in the country is fairly high. However there are still certain areas in which we require the help from foreign .. untries. It is in order to fill up the gap between what we have and what we require that we seek the help of toreign countries.

# Complaint against Administration in Jessop & Co.

'65. SHRI LUTFAL HAQUE: the Minister of HEAVY INDUSTRY be pleased to state:

- (a) whether Government have recrived any complaint regarding adnunistration in Jessop & Co.; and
- (b) if so, the nature of the comptomt and the action taken in this regard?

THE MINISTER OF HEAVY IN-DUSTRY (SHRI T. A. PAI): (a) and (b). Certain allegations regarding monipulation of accounts, favouritism etc, were made against the management of Jessop and Company recently. These were duly investigated and found to be without any substance.

## Coal Mine Workers' dues from Erstwhile Coal Mine Owners

\*66. SHRI ROBIN SEN:

Will the Minister of STEEL AND MINES be pleased to state:

- (a) the steps taken by Government to collect the dues of coal mine workers from coal mine owners and pay them to the workers; and
  - (b) the main features thereof?

THE MINISTER OF STEEL AND MINES (SHRI K. D. MALAVIYA): (a) and (b). A provision has been made under the legislation for the taking over of management and na-

tionalisation of coking and non-coking coal mines to recover on a preferential basis the dues of the workers out of the amount payable to the erstwhile coal mine-owners. The claims for arrear dues out of compensation amounts will have be filed before the Commissioners of Payments. In the case of coking coal mine the Commissioner of Payments has already been appointed and claims have been filed before him. In case of non-coking coal mines the Commissioner will be appointed shortly.
