Scheme to Change Course of Jamuna in Delhi

- \*1673. SHRI C. JANARDHANAN: Will the Minister of IRRIGATION AND POWER be pleased to state:
- (a) whether there is any proposals before Government to take up a scheme for changing the course of river Jamuna in Delhi;
- (b) if so, the main features thereof and the estimated expenditure; and
  - (c) the decision of Government thereon?

THE MINISTER OF IRRIGATION POWER (DR. K. L. RAO): AND The course of the Yamuna river in Delhi territory is fixed by a number of control structures consisting of barrages bridges and therefore it is not possible to change it. The Delhi Administration have, however, proposed a scheme for training the river within Delhi territory by dredging with the object of making it flow along a desired channel specially during non monsoon period. The object is (1) to maintain a channel in a suitable alignment upstream of Wazirabad Barrage to prevent erosion of flood banks; (2) to maintain a channel in front of the ghats between Wazirabad barrage and old railway bridge and(3)(o improve the channel conditions in front of the Yamuna Barrage. The scheme provides for the procurement of two dredgers and their operation for a period of three years. It is estimated to cost Rs. 34 lakhs. The scheme has been examined by the Central Water and Power Commission and is b.ing recommended to the Planning Commission for approval.
