prisenars who are in jail and who are connected with political parties as political, prisoners and treat them accordingly. The treatment that is meted out to them now cannot be described. It is worse than the treatment meted out during British days. I want to know whether you are going to consider this aspect that political prisoners should be given treatment like political persons. Would you kindly do this?

SHRI K.C. PANT: This is going a little away from the main Question. I would like to have your guidance, Sir.

MR. SPEAKER: You reply so far as it is relevant to this Question.

SHRI K.C. PANT: On the question of suspension of two police officers, I remember, this House went into the question. The hon. Member put the question in the last session and my colleague, Shri Siddhartha Shankar Ray, replied to him. He went into the matter and explained the whole thing in detail, as far as I can remember. What the latest position is on that score I do not know. I have dealt with the Question as jt has been posed here.

SHRI DINEN BHATTACHARYYA; On the first day of the all-party meeting, Mr. Siddhartha Shankar Ray agreed that those two police officers will be suspended. Even Mr. Bejoy Singh Nahar agreed. Why were they not suspended?

MR SPEAKER: Does it relate to the same incident?

SilRi DINEN BHATTACHARYYA: I request you, if you want, to take up the question some time later. This relates to the same incident. Let him reply to that.

SHRIK C. PANT: It is quite right that it relates to this incident. This is why I said that during the last session, this particular point was taken up by the hop. Member.

SHRI DINEN BHATTACHARYYA: You kindly go through your papers.

Will the Minister of INDUSTRIAL DEVELOPMENT be pleased to state:

- (a) whether any selection has been made about the model of small car to be manufactured in the country;
- (b) the capital investment on the small car project and the time by which the production is expected to start; and
- (c) the role played by the National Industrial Development Corporation in the selection of the model and its suitability to, Indian conditions and with the fixation of ex-factory and total selling prices?

THE MINISTER OF INDUSTRIAL:
DEVELOPMENT (SHRI MOINULA
HAQUE CHOUDHURY): (a) The
reports of the study groups have
been received. They are under study
and consideration of the Government.

- (b) The investment on the project will, depend on the car selected for manufacture, Broad estimates of such capital cost have however, been made by a Committee of officials appointed to go into all relevant matters related to the establishment of the public sector car project and these are under scrutiny. No firm estimate of the capital cost can, therefore, be furnished at this stage. It is expected that initial production may start within a period of 3 years from the date investment decisions, have been taken after selection of the model and the collaborator.
- (c) The N.I.D.C. was appointed to a saist the Committee of officials set up by the Government to examine all relevant aspects relating to the establishment of a car project in the public sector including the conduct of discussions with interested foreign from its regard to the technicial

financial and commercial aspects of their proposals and evaluate them in comparative terms and submit suitable recommendations for the considerations of Government.
